

SALT LAKE CITY NOTICE OF PUBLIC HEARING

February 21, 2023, at 7:00 p.m.

NOTICE IS HEREBY GIVENT THAT ON Tuesday, February 21, 2023, at 7:00 p.m. a public hearing will be held before the Salt Lake City Council to accept public comment on proposed projects and activities to be undertaken with federal funds under the following U.S. Department of Housing and Urban Development (HUD) programs:

• HOME Investment Partnerships Program – American Rescue Plan (HOME-ARP) Allocation Plan

Through the American Rescue Plan Act (ARPA), Salt Lake City was notified on April 28, 2021, about a one-time, supplemental allocation of U.S. Housing and Urban Development (HUD), HOME Investment Partnerships Program (HOME-ARP) funds in the amount of \$3,533,195. HOME-ARP funds may be used to create affordable housing opportunities, tenet based rental assistance, supportive services, homeless prevention services, housing counseling, or purchase and development of non-congregate shelter for qualifying populations. These populations include:

- Homeless
- At risk of homelessness
- Fleeing or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking
- In other populations where providing supportive services or assistance would prevent the family's homelessness or would serve those with the greatest risk of housing instability
- Veterans and families that include a veteran family member that meet one of the preceding criteria

To target the HOME-ARP funds to the unique needs these populations within recipient communities, HUD required all recipients to undertake an in-depth Community Assessment, including engaging in consultation and public participation processes, conducting an inventory and gap analysis, then draft and submit an Allocation Plan, outlining the activities that would be carried out with HOME-ARP funding.

• Substantial Amendment to the Salt Lake City FY 21-22 Annual Action Plan As part of the HOME-ARP Allocation Plan approval and submission, Salt Lake City is also required to submit a Substantial Amendment to the Salt Lake City FY 2021-2022 Annual Action Plan, to include the HOME-ARP funding made available during the corresponding program year, and approve the submission of the HOME-ARP Allocation Plan.

This Public Hearing will use a hybrid meeting format. Hybrid meetings allow people to join online through Webex or in-person at the City & County Building, located at 451 South State Street, Room 326, Salt Lake City, Utah 84111.

Prior to giving final approval of the Substantial Amendment and HOME-ARP Allocation Plan, the Salt Lake City Council will consider and review all public comments, as well as recommendations provided by Mayor Erin Mendenhall.
