## Analysis in Brief

Describing the characteristics of Salt Lake City's population and households at the neighborhood level reveals much more about the diversity, opportunities, and challenges within its population than does a set of citywide metrics. The tables and maps in this data book provide many opportunities to understand the city's diverse characteristics in great detail. Several variables included in this book have a visible geographic divide, with I-15 drawing a boundary that leaves City Council Districts 1 and 2 to the west and Districts 3 through 7 to the east. Some of the visibly different characteristics of the western districts are:

- Larger shares of the populations identifying as Hispanic or Native Hawaiian/Pacific Islander
- Younger populations, higher shares of children, and higher shares of large households than the central or east areas of the city
- Lower educational attainment in adults

However, not all of the topics in this data book demonstrate an east/west divide. Nor should the east side be considered uniform. For example, City Council District 4, in the center of Salt Lake, is unique in many respects. In some estimates, it seems more similar to western districts, but in others, the eastern districts. It has:

- The lowest estimated median household income in the city (much more similar to western districts than eastern districts)
- The highest shares of households in poverty (also in range with western districts)
- Average educational attainment: over half of adults have a Bachelor's Degree or higher, which is much closer to the shares of eastern districts, and higher than the city's overall share (45%)
- The highest share of nonfamily households and people living alone of all districts, by far, which is very distinct from western districts

Some characteristics don't follow any apparent geographic pattern. Dispersed throughout the City Council Districts are areas with the highest shares of the non-Hispanic Asian population

with Districts 2, 4, and 6 having the highest overall shares. In considering a variable not included in this book (foreign-born by period of entry), we can see some alignment with higher shares of non-Hispanic Asian population and areas with larger populations of foreign-born individuals who entered the US after 2010.

The 2020 Salt Lake City Data Book presents maps and data sharing the most recent data about the city's population, housing units, and related characteristics. Salt Lake City Corporation sponsored the research.

This book utilizes two primary data sources:

- 2019 subcounty population and housing estimates produced by the Kem C. Gardner Policy Institute.
- Demographic and socioeconomic information from the American Community Survey 2014-2018 5-year Estimates (ACS).

The ACS estimates for population and households provide the denominator for all socioeconomic characteristics. The 2019 subcounty estimates are not (and should not be) used to derive shares of ACS data.

More information about these sources is in the Subcounty Population and Household Estimates and Data Notes sections of this document.

### Geography

The Gardner Institute created the census tract codes shown in maps and tables as an abbreviated method of referring to tracts (W1, C1, E1, etc.). The letters W, C, and E in tract codes roughly correspond to the west, central, and east areas of the city. The Reference Figures at the end of the book show additional geographic reference information with the tract boundaries, such as streets, community council boundaries, and where people live within the tracts. Importantly, Tract W14 has most of its area within Salt Lake City, yet most of the population lives in bordering West Valley City. See the Geography Notes section for additional information about boundaries used in this atlas.

# Subcounty Population and Household Estimates

## **Population and Households**

Each year the Kem C. Gardner Policy Institute produces population and household estimates using the housing unit method. The total population of Salt Lake City grew from 186,411 at Census 2010 to 199,678 in 2019, an increase of 13,267 (7.1%).<sup>1</sup> Council Districts 4, 7, and 3 added the most new residents in the same time period. Tract C2 (Capitol Hill/Fairpark), was the highest growth tract, adding 2,367 residents and more than doubling in population. The next highest growth areas were in Tracts W7 (Jordan Meadows), E14 (Sugar House), C10 (Downtown).

Tract C2 (Capitol Hill/Fairpark), mentioned above, had not only the highest population growth but also the fastest growth rate (155 percent). The next highest growth rate was in Tract C10 (Downtown, 105%). Other fast-growing tracts were the Salt Lake City portion of Tract E20 (Sugar House), C11 (Central City), and E14 (Sugar House). These tracts grew 83%, 78%, and 73%, respectively.

The city's total household count grew from 74,499 at Census 2010 to 83,425 in 2019, an increase of 8,926 (12.0%).<sup>2</sup> Households are occupied (rather than vacant) housing units. Tract C10 (Downtown) gained the most new households, at 1,168. Tract C9 (Downtown) closely followed with 1,134 new households. Tracts C2 (Capitol Hill/Fairpark), E14 (Sugar House), and C11 (Central City) also gained many new households (932, 855, and 740, respectively).

## **Tenure**

Renter-occupied households in the city grew by 8,485 (22.1%) since Census 2010, bringing the 2019 total renter-occupied units to 46,926. This represents 56% of the city's occupied units. Sixteen tracts gained at least 100 new renter households. Tract C9 (Downtown) gained the most, with 1,134 new renter households, followed by C10 (Downtown, 1,100 new units) and Tract C2 (Capitol Hill/Fairpark, 930 new units).<sup>3</sup>

Owner-occupied household growth in Salt Lake City was far smaller than renter household growth. Owner households increased by 442 (1.2 percent), for a total of 36,500 owner-occupied units in 2019. This represents 44% of the city's occupied units. Tract C10 (Downtown) gained the most owner households (68 households). Tract E17 (Sugar House) and Tract C25 (Sugar House) followed, gaining 30 and 21 owner households.

Tract E3 (University of Utah) has the highest renter share of households in the city, at 98 percent. Thirteen additional tracts also have at least 75 percent of households estimated as renter-occupied. Tract E2, covering part of the Avenues and Federal Heights neighborhoods and bordering the university, has the highest owner share of households in the city, at 94 percent.

## **Methodology and Notes**

The estimates are based on the housing unit method, which uses building permit data to estimate changes in housing units, and then infers population change based on the housing unit changes. Households are differentiated by tenure (renter-occupied and owner-occupied). Changes in group quarters populations—people in group living situations such as dormitories and jails—are also accounted for where data are available. All 2019 estimates refer to a July 1, 2019 reference date. Note that some census tracts have large populations outside the Salt Lake City boundary, but the estimates shared here reflect only the populations located within the city's 2019 boundary.

The source of building permit data was Construction Monitor, a company that performs ongoing collection of permit data.<sup>4</sup> Permit data were geocoded and analyzed by the Kem C. Gardner Policy Institute. We made several edits and additions to building permit data in order to include permits not reported by Construction Monitor and to reflect intensive internal research on Salt Lake City construction. The population and household estimates in this section are not related to American Community Survey (ACS) data. For household and population estimates from the ACS 2014-2018 dataset, see the Data Notes reference section of this book. The ACS household and population estimates serve as the denominators or base numbers used for all other sections of this book (Age, Race and Ethnicity, Households, and Socioeconomics).

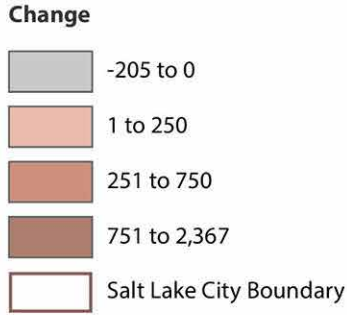

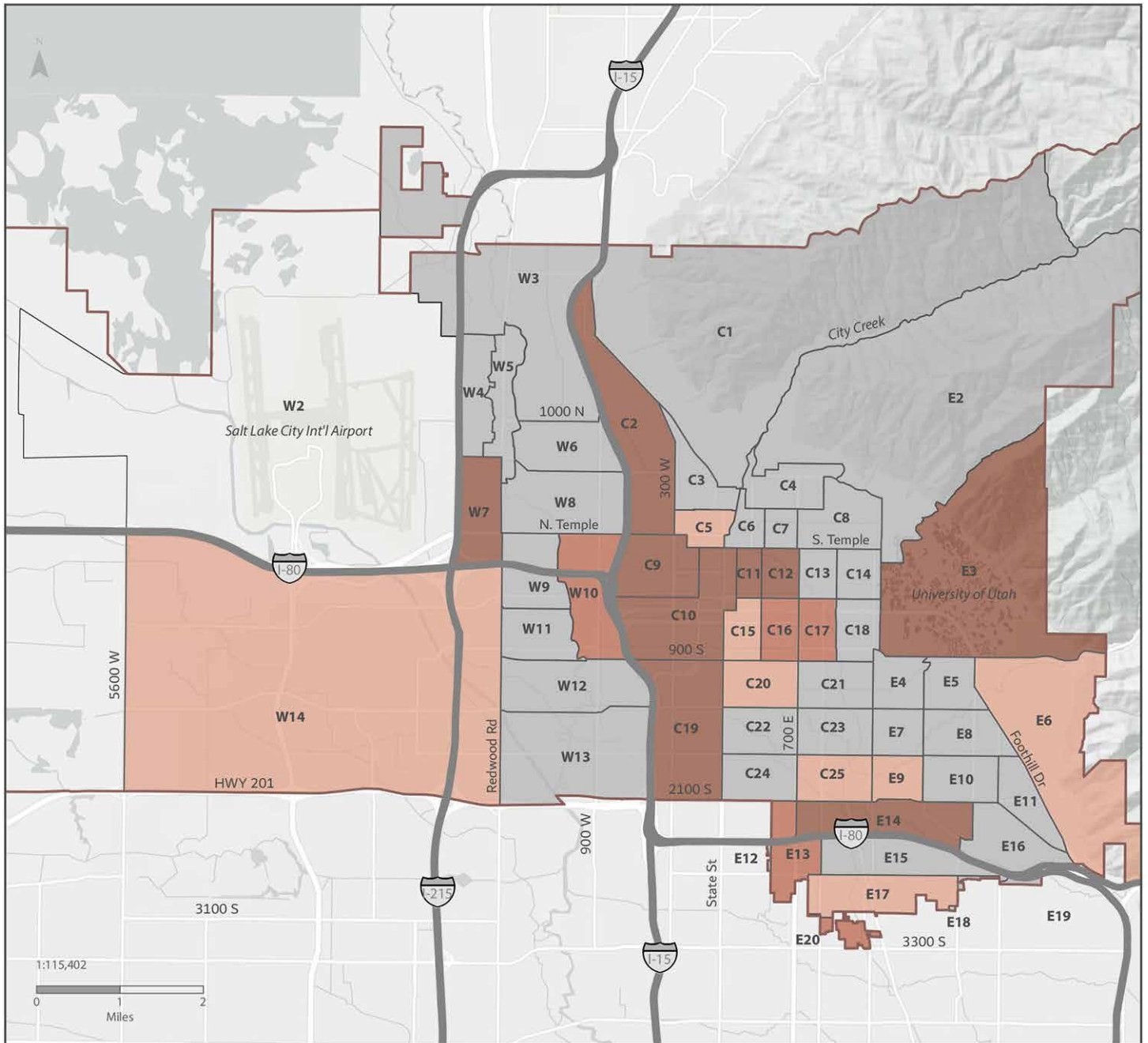
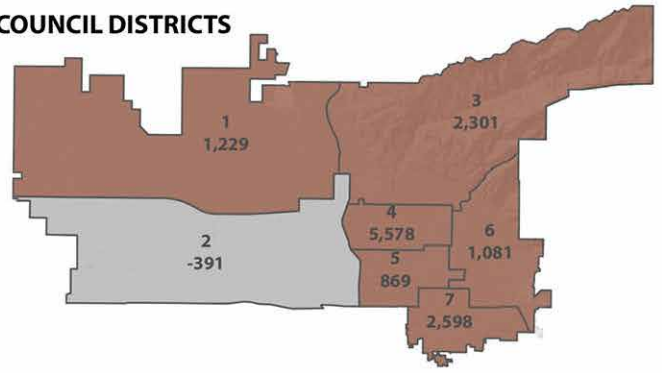

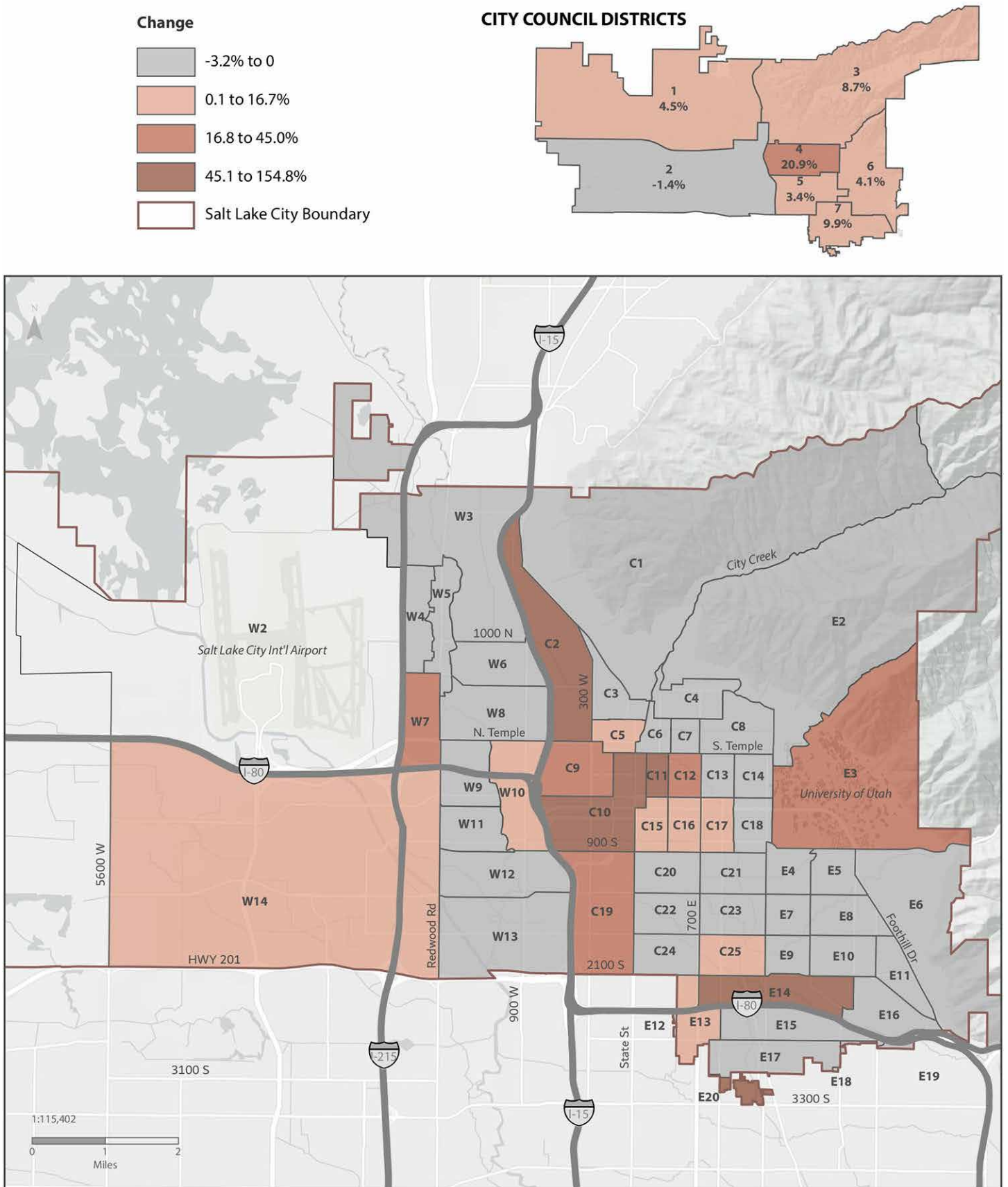

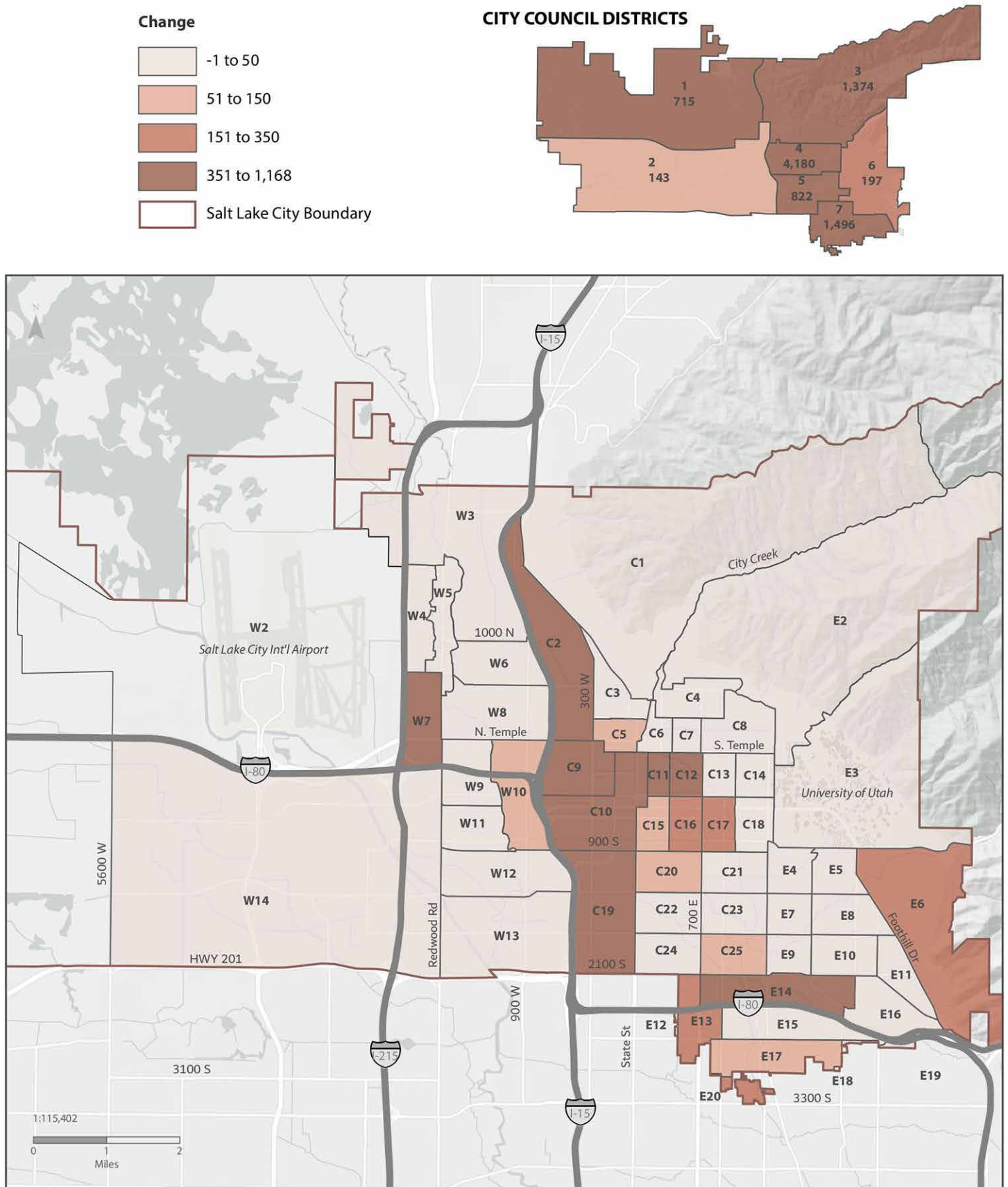

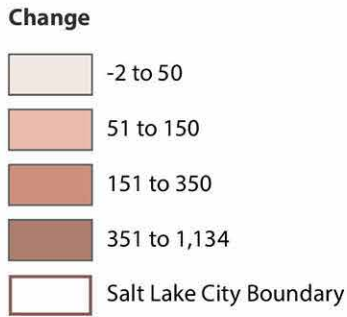

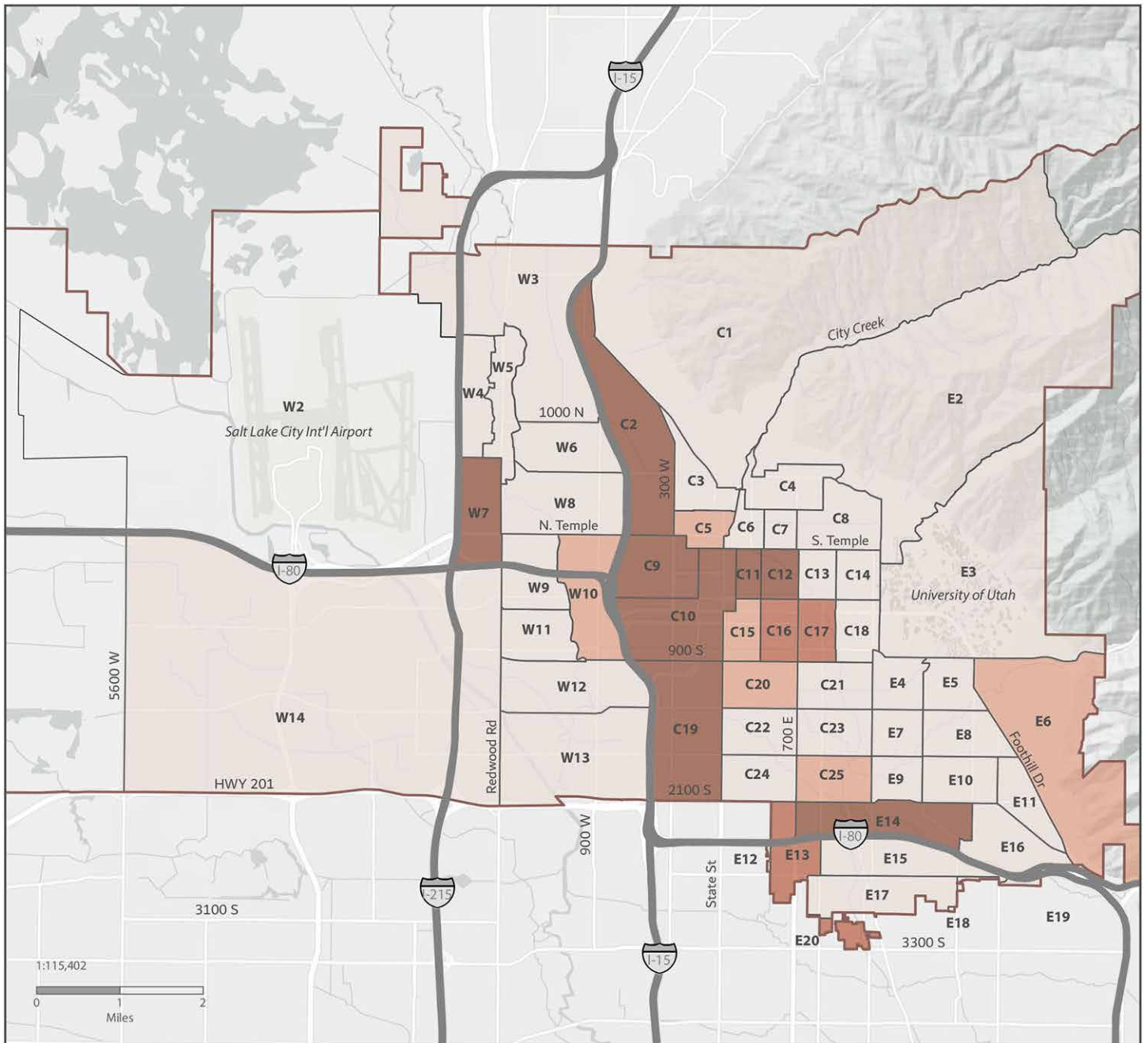
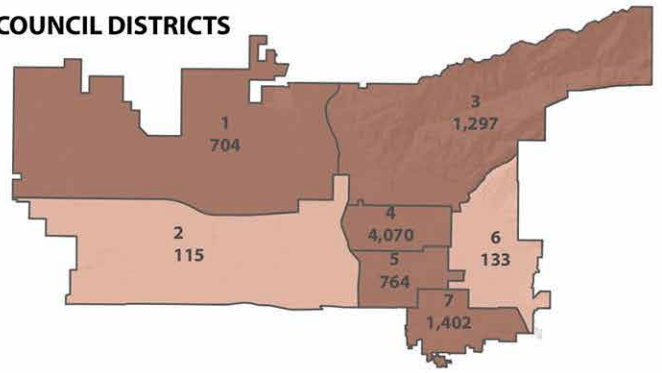

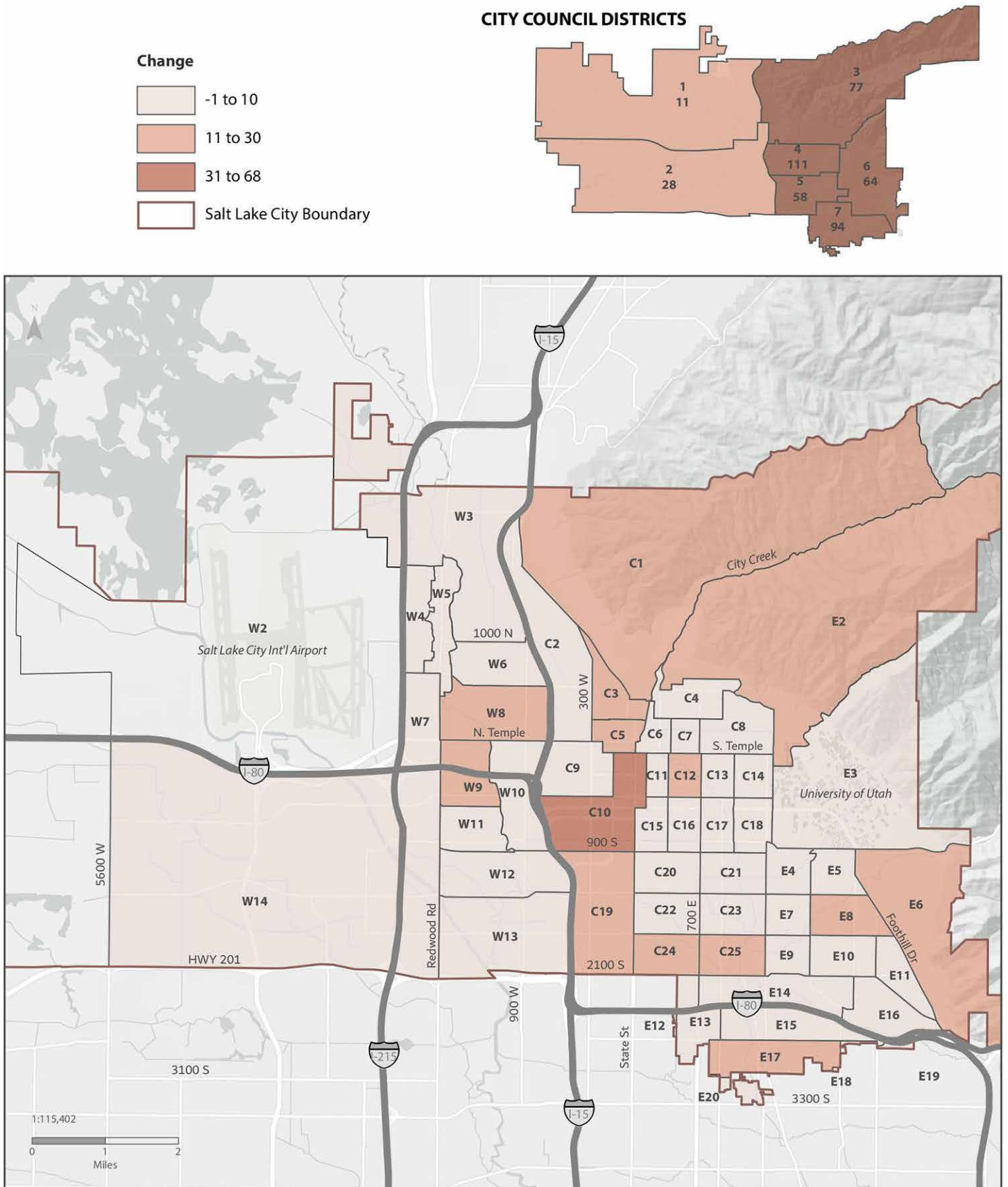

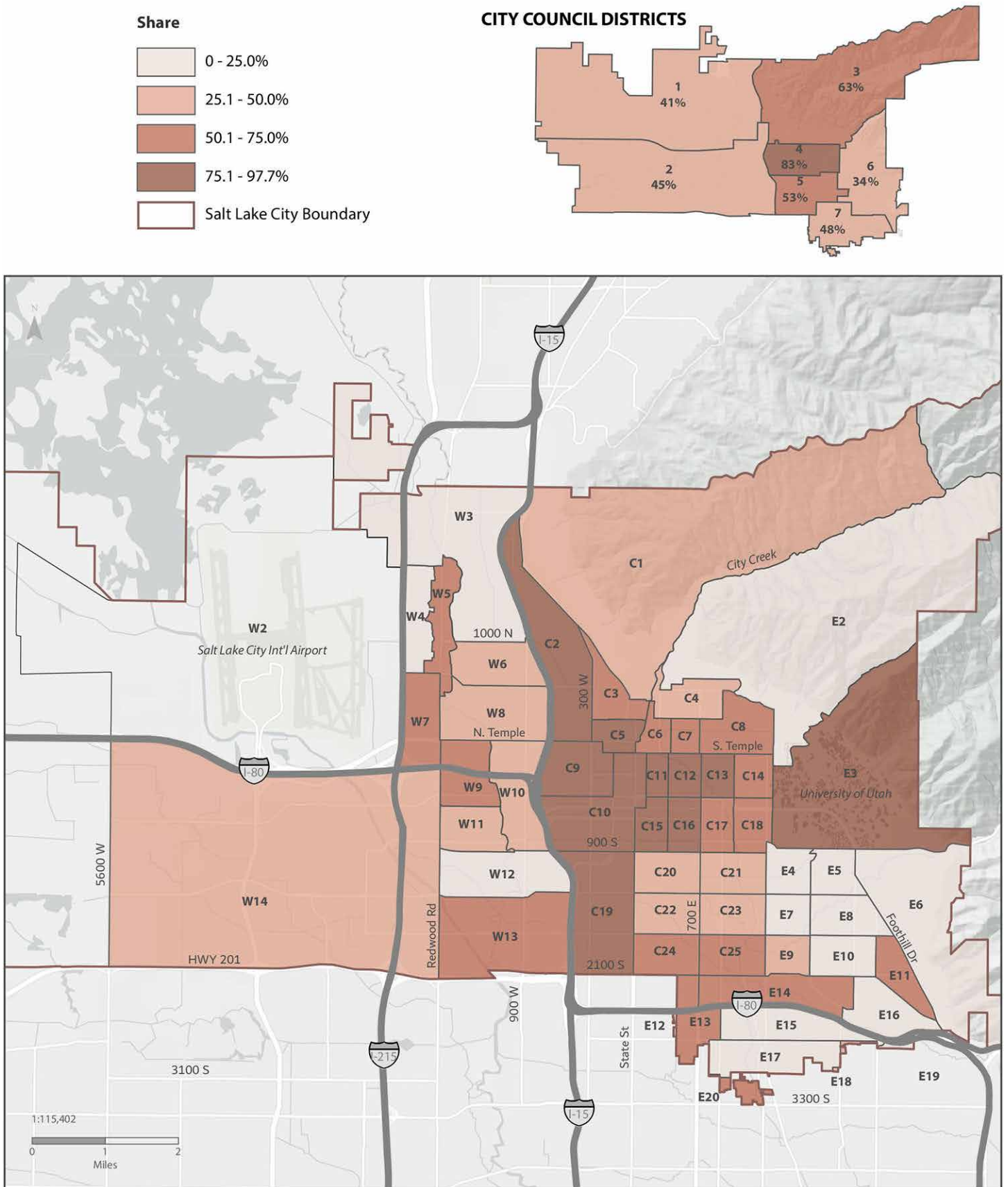

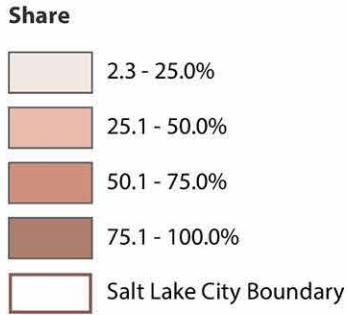

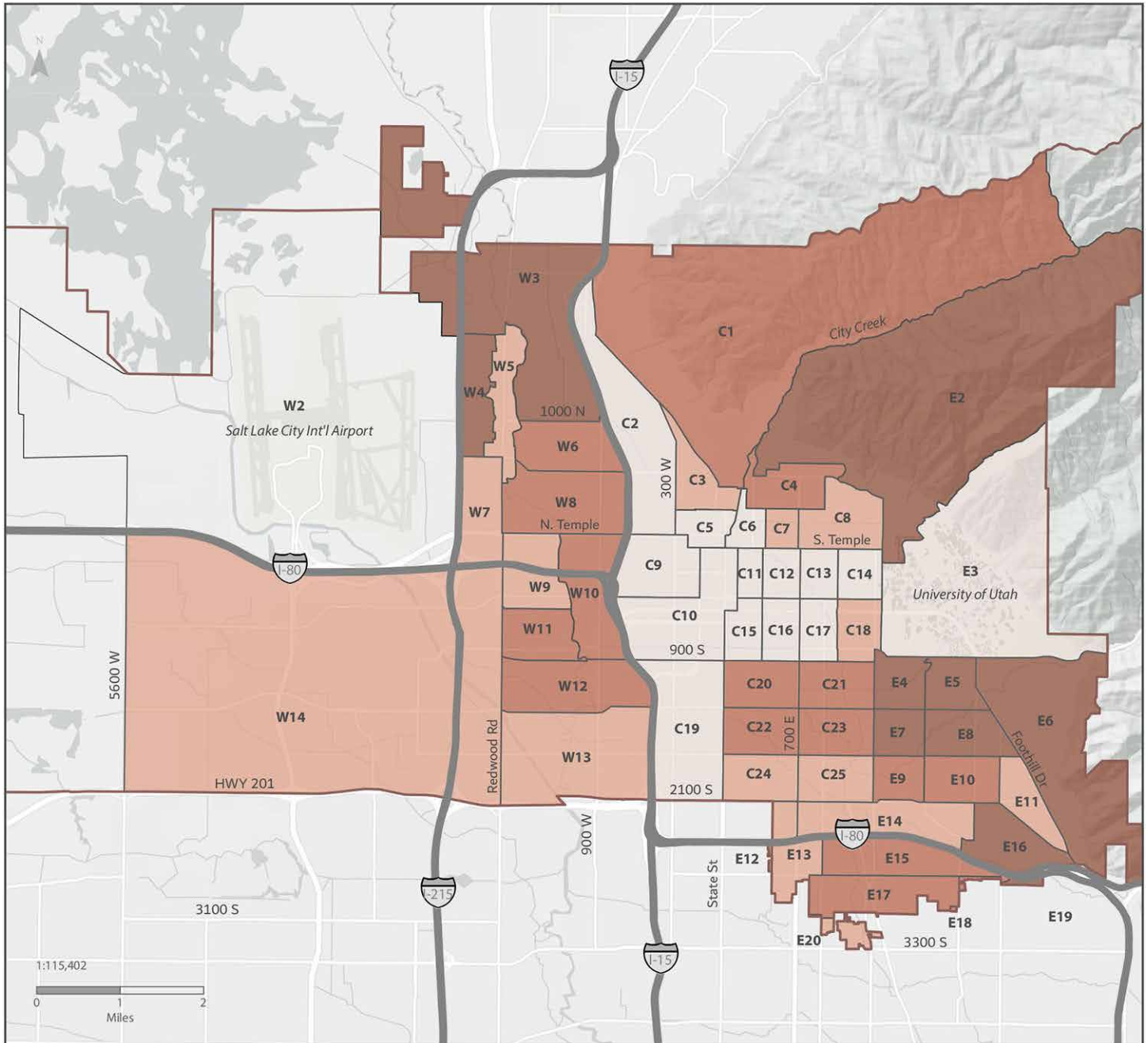
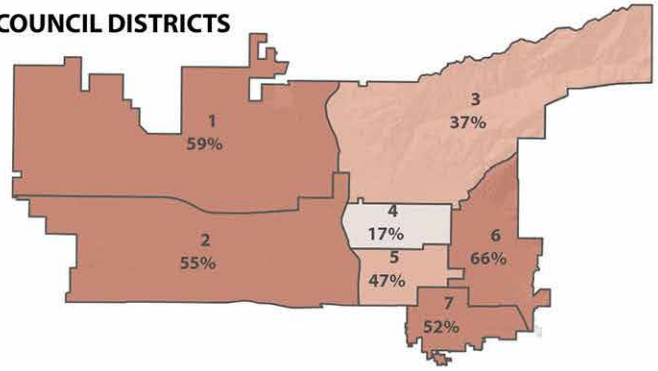

# Race and Hispanic or Latino Origin

Salt Lake City is more racially and ethnically diverse than the state, with over one-third (34.6%) of the population being racial minorities or of Hispanic or Latino origin. Statewide, just over 1 in 5 residents (21.9%) identify as a minority. West Valley City is the only city with a higher minority population share than Salt Lake City. City Council Districts 1 and 2 are minority-majority. The rest of the city council districts are predominantly non-Hispanic white. City Council Districts 4 and 5 are nearly three-quarters white, and Districts 3, 6, and 7 are over 82% non-Hispanic white.

## Hispanic or Latino

Both statewide and in Salt Lake, the Hispanic or Latino population is the largest minority population. These sizeable populations translate to 13.9% of the state and 21.6% of the capital city population. City Council Districts 1 and 2 have the highest shares of Hispanic or Latino population at 48.3% and 47.8%, respectively. Over half of the population of five tracts west of I-15 identify as Hispanic or Latino (W8, W7, W12, W4, and W9).

## Non-Hispanic Asian

In Salt Lake City, the second-largest minority population is those who identify as non-Hispanic Asian at 5.3%. Districts 6 and 4 have the highest shares of the population who identify as Asian, at 7.9% and 7.5%, respectively. The five tracts with the highest share of the non-Hispanic Asian population are dispersed throughout the City (E11, W14, C9, E12, E3).

## Non-Hispanic Other or Multi-Racial

In Salt Lake City, the non-Hispanic other or multi-racial population is the third-largest minority group at 3.0% of the total population. City Council District 2 had the largest share (4.9%), followed by District 4 (3.6%). Tract W10 had the highest share citywide, with 10.9%.

## Non-Hispanic Black or African-American, American Indian or Alaska Native, and Native Hawaiian or Other Pacific Islander

These three populations make up 4.7% of the Salt Lake City population, with the non-Hispanic Black or African-American population being the largest of the three at 2.2% citywide (over 4,200 people). 1.4% of Salt Lake City's population identify as non-Hispanic Native Hawaiian or Pacific Islander, and 1.1% identify as non-Hispanic American Indian or Alaska Native (about 2,800 and 2,200 people, respectively). City Council District 2 has larger shares of population than the city for all three groups and the highest non-Hispanic Hawaiian or Pacific Islander share in the city (4.7%). City Council District 5 has the highest share of the non-Hispanic American Indian or Alaska Native population (3.2%) and District 1 has the highest share of the non-Hispanic Black or African-American (4.1%).

Five tracts across the central and western portions of the City (C12, C15, W13, W5, and C11) have 7% or more of the population identifying as non-Hispanic Black or African-American. Similarly, the tracts with the highest shares of non-Hispanic American Indian or Alaska Native populations (3% or more) are in the west and central parts of the City (W10, C21, W4, C19, W9). The tracts with the largest share of Native Hawaiian or Pacific Islander are all in the western part of the City (W5, W14, W11, W13, W7).

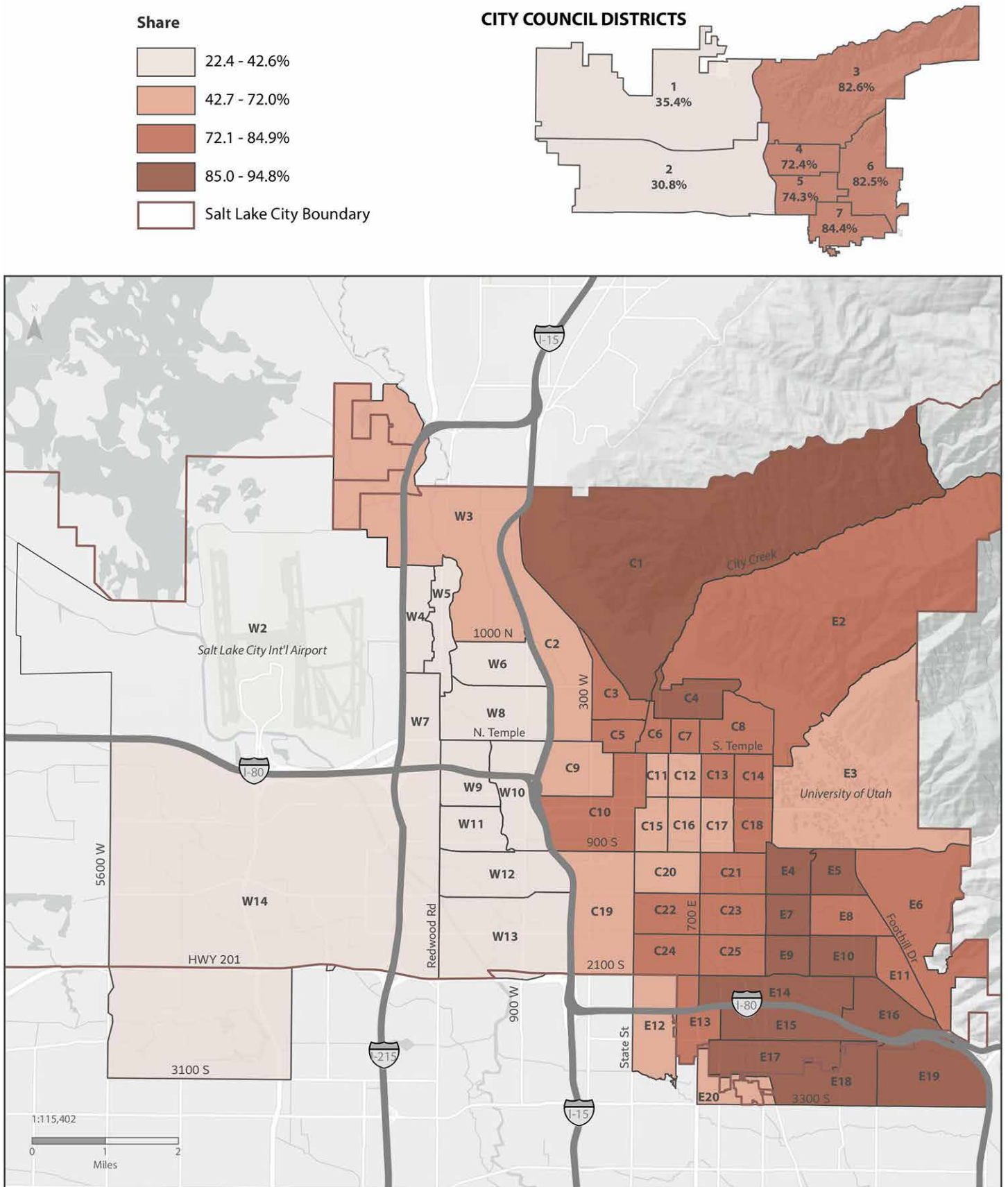

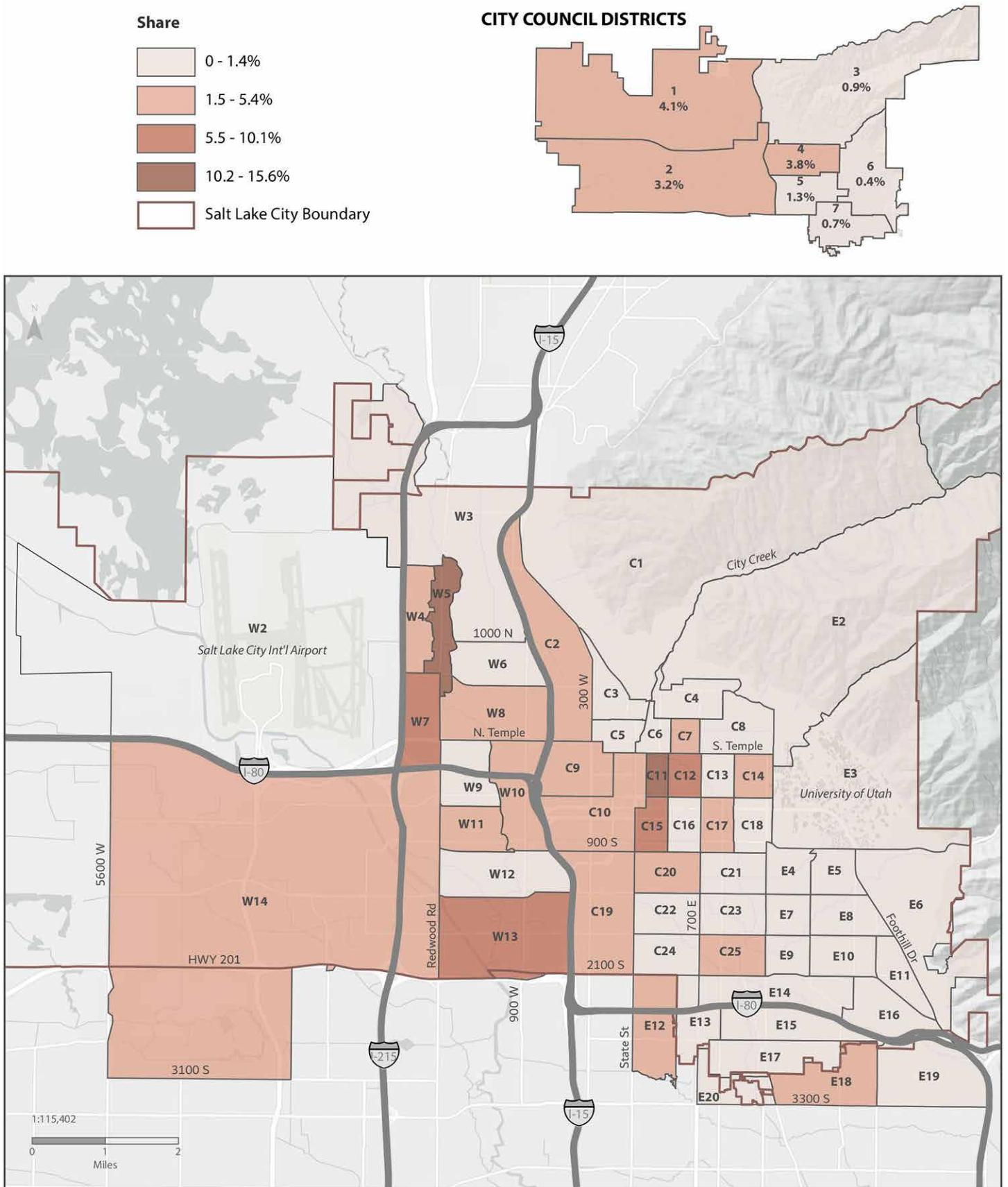

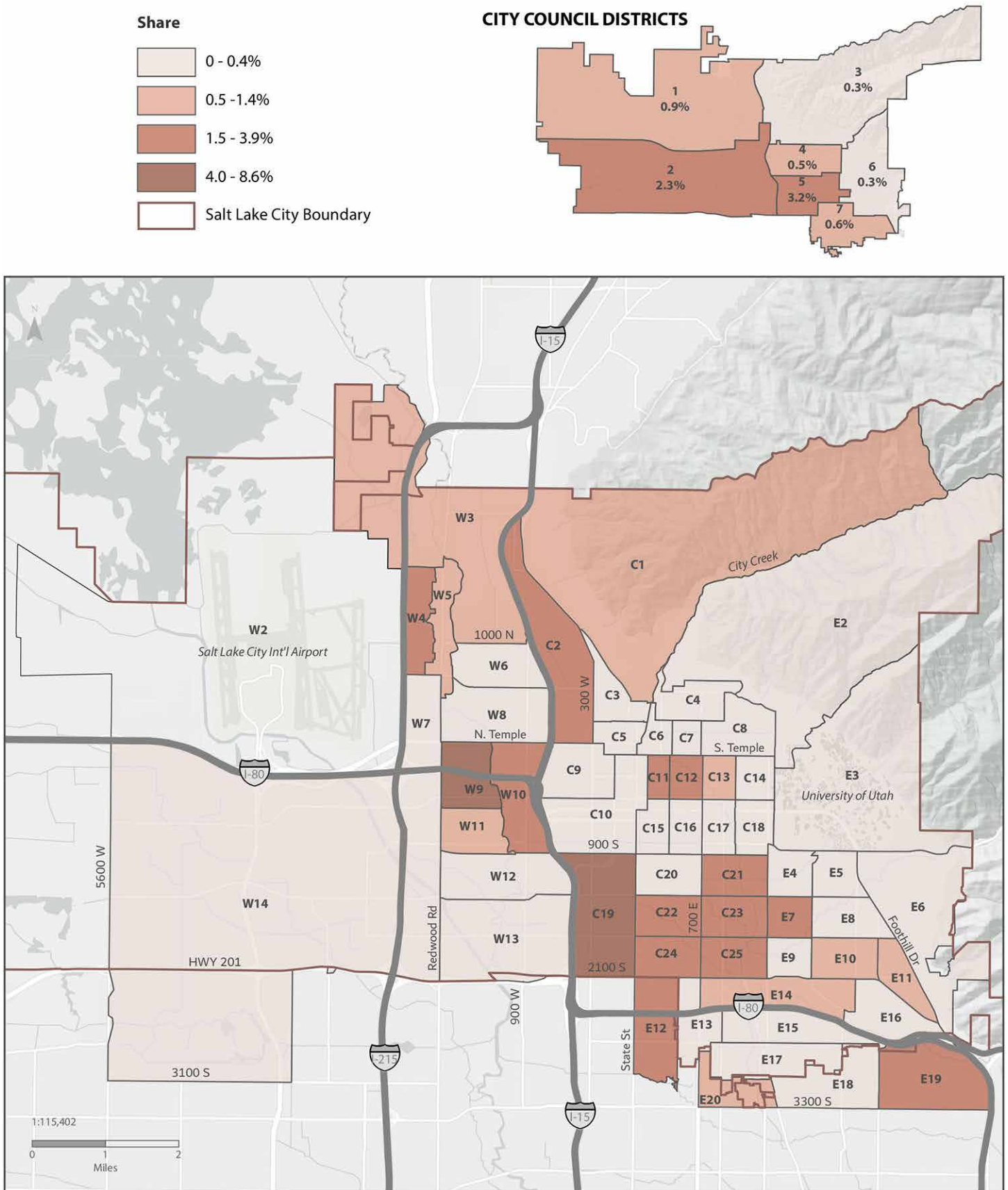

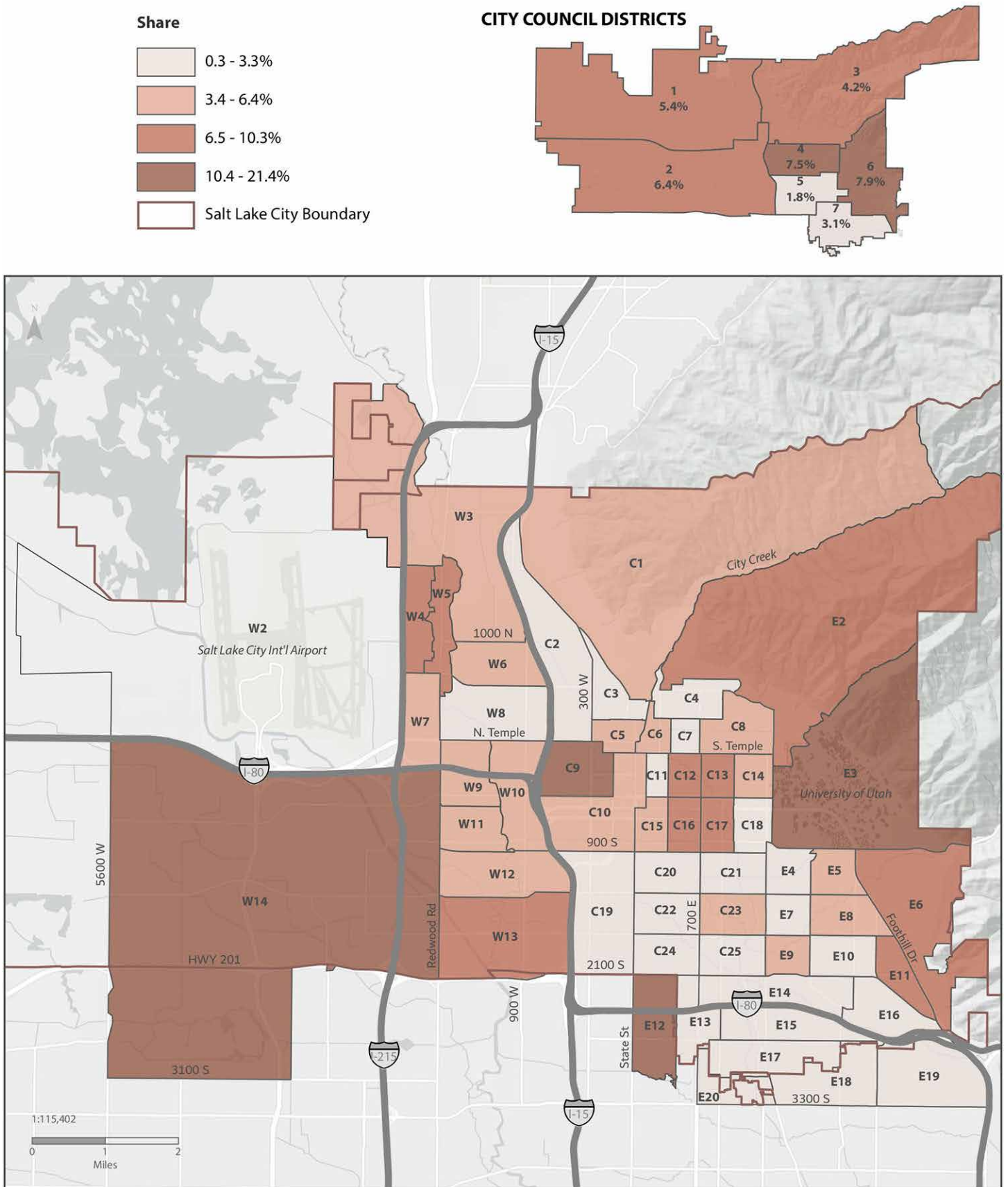

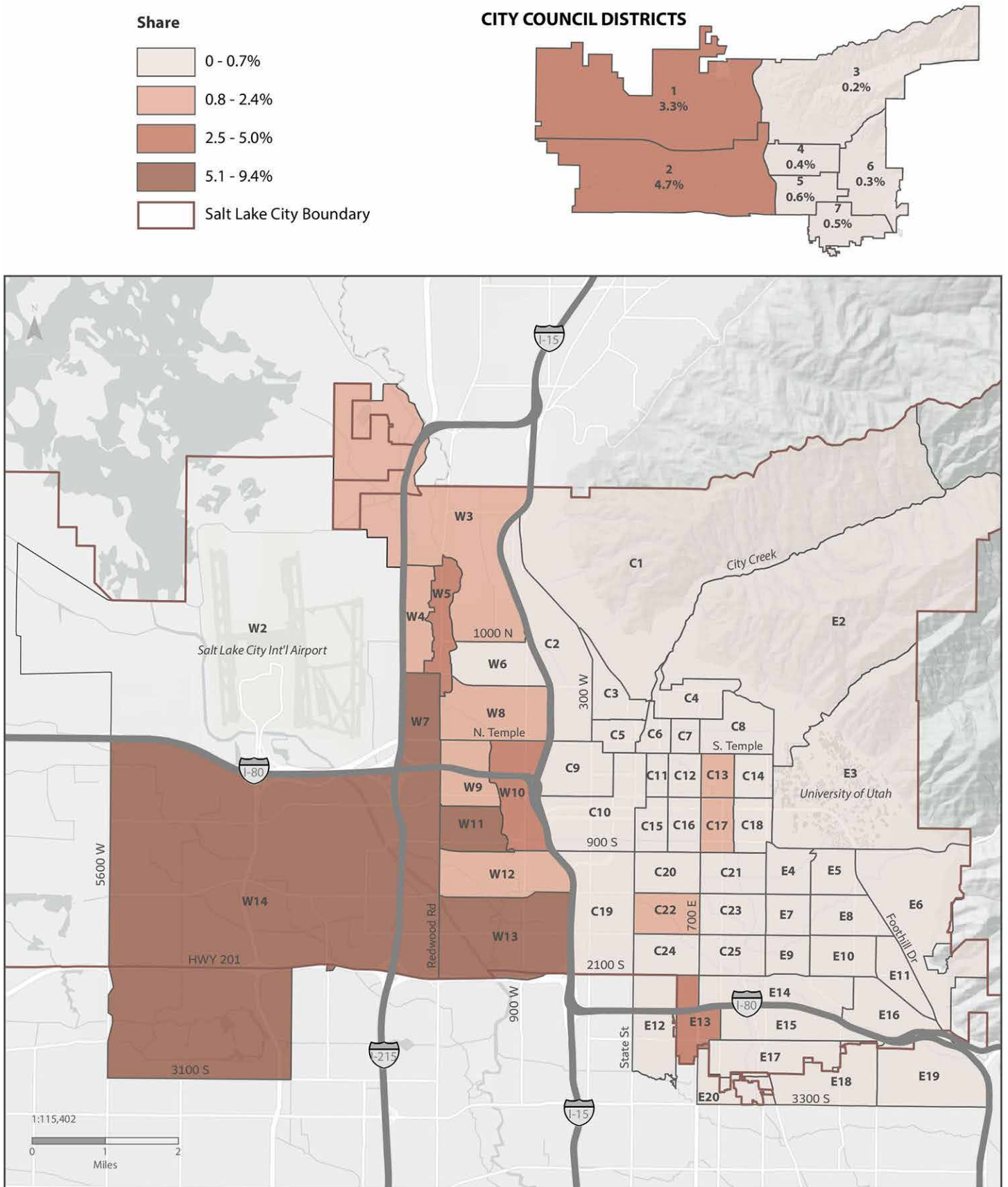

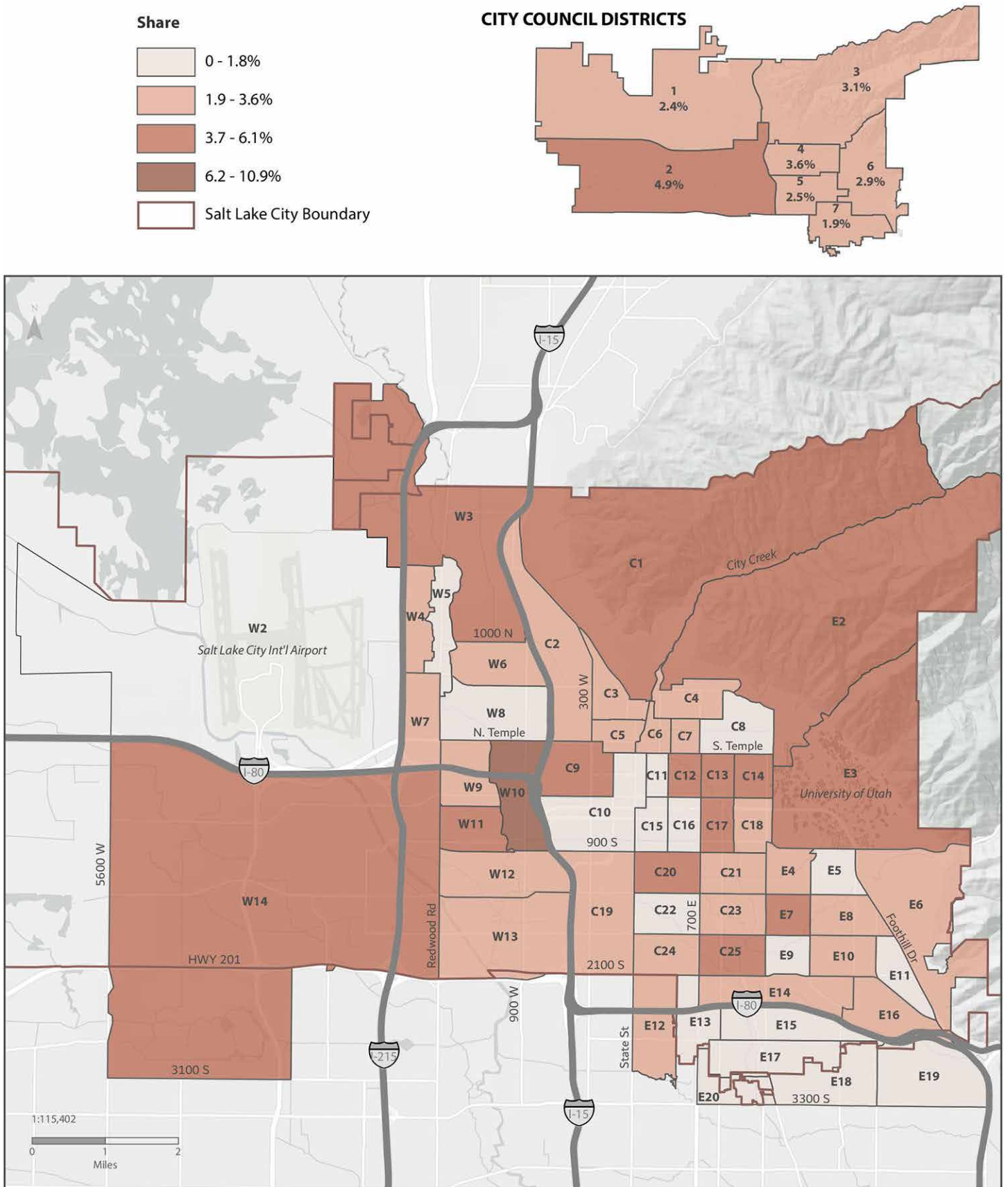

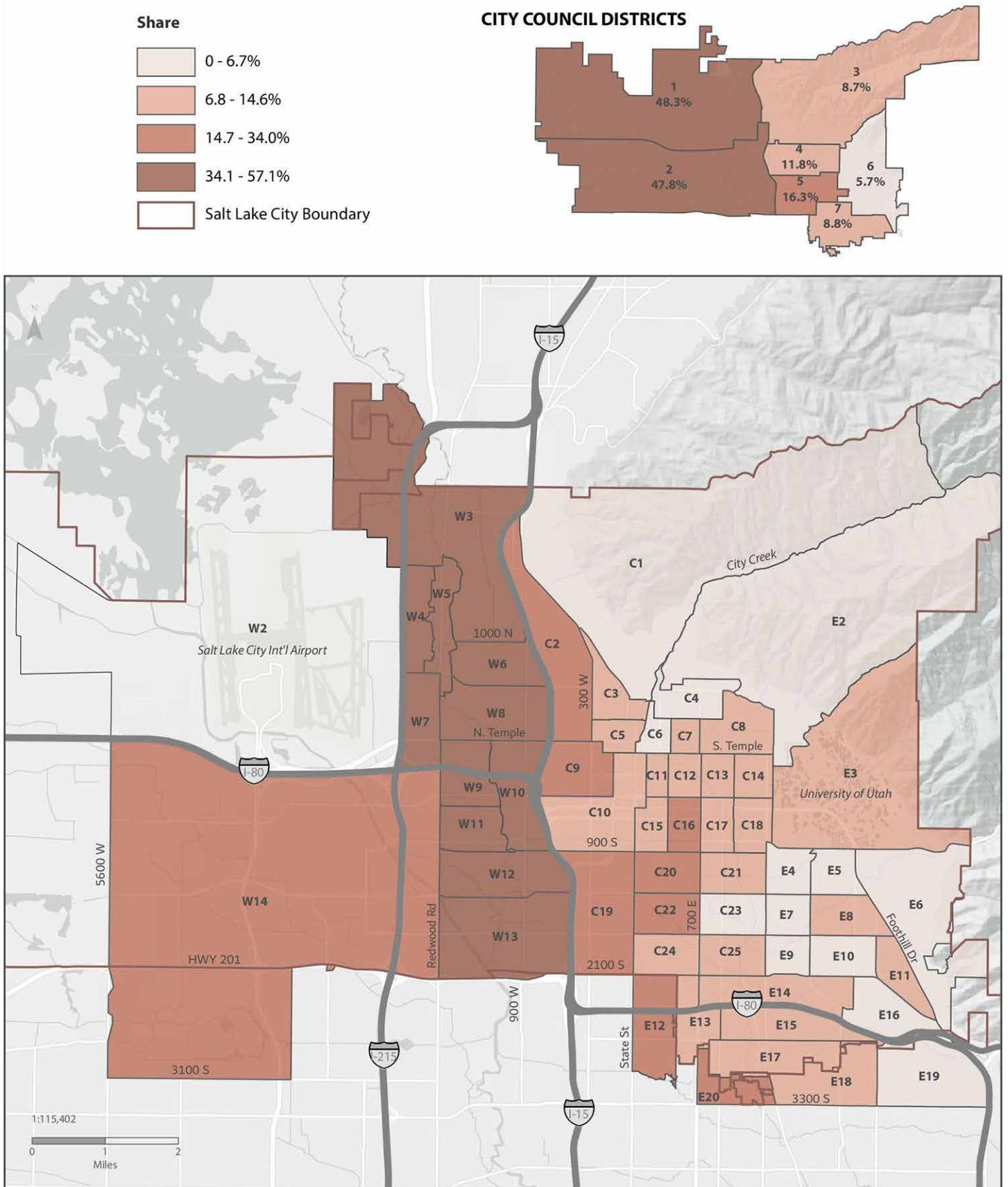

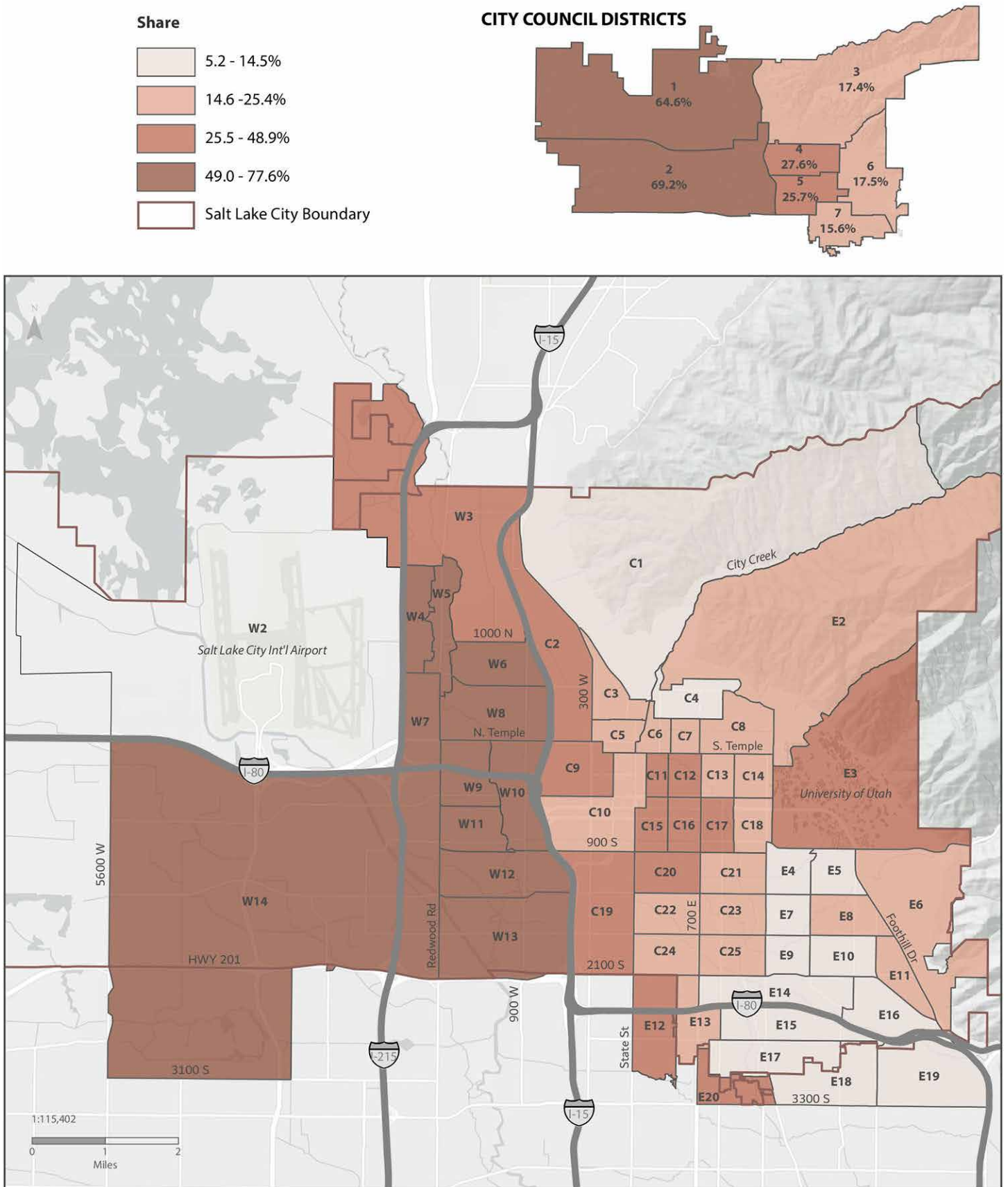

Overall, Salt Lake City is older than the state. The median age in Salt Lake is 32.0, while it is 30.7 statewide.<sup>6</sup> Salt Lake City's higher median age is due to a lower share of children and a large working-age population. The neighborhoods west of I-15 have higher shares of Salt Lake City's children than other parts of the city, while the central part of the city is home to many working-age adults.

### Children (Under 5 and School-Age)

Statewide, 30% of residents are children (8.3% under age 5, 21.8% between ages 5 and 17). In Salt Lake City, just over one-in-five city residents are children (6.4% under age 5, 14.2% between 5 and 17). City Council District 2 has the highest share of both of these groups, with 9.2% under 5 and 22.8% between ages 5 and 17 (City Council District 1 follows closely behind). City Council District 4 has the lowest share across both groups, with children making up less than 7% of the population. The tracts that stand out with the highest and lowest shares align with the west and central parts of the city. Though the tracts with the highest shares of youth aged 5 to 17 are in the west, a few eastern tracts also have notably high shares of this age group.

### College Age

Salt Lake City is home to the University of Utah, Westminster College, Salt Lake Community College South City campus, Neumont University, and the LDS Business College. These campuses, in addition to many employment options, contribute to five tracts in the city having more than one in four people in the college-age (18 to 24) group. In Tract E3, home to the University of Utah, over half of the population is aged 18 to 24. The remaining four tracts are in City Council District 4, where 23.5% of the population is college-aged – C18 (34.6%), C13 (29.4%), C14 (28.8%), and C12 (27.3%). City Council District 5 has the lowest share of the college-aged population, with three tracts (E16, E7, and E6) having less than 5% of the population in that age group.

### Working Age

Salt Lake County is the economic center of the state. The resulting job opportunities lead to a higher working-age share of the population in the county than in the state (52% compared with 48%). Over half (55.2%) of Salt Lake City's population is working-age (25 to 64 years). Over 60% of both City Council Districts 4 and 5 are working-age residents. Tract C10 has the highest share of working-age adults with 71.1%. Five additional tracts (C16, C6, C11, C17, C7) in the central part of the city have at least two-thirds of their population between ages 25 and 64. Less than half of the populations of City Council Districts 2 and 6 are working-age, the lowest in the city.

### Retirement Age

The share of the retirement-age population (aged 65 or over) is very similar at the state (10.5%), county (10.3%), and city-level (10.8%). Within Salt Lake City, City Council Districts 3 and 6 have the highest shares of retirement-age residents (15.4% and 14.1%, respectively). At least one in five residents is 65 or over in five tracts throughout the City (C5, E2, E20, E6, C1). City Council District 2 has the lowest share of the retirement-age population at 7.8%. Three tracts (W9, E3, and C7) have less than 5% of their populations in this age group.

### Median Age

As mentioned previously, Salt Lake City is older than the state, with a median age of 32.0 years compared to 30.7 statewide. City Council Districts 3 and 6 have the highest median age – 37.2 and 35.8, respectively. There are six tracts in the city with a median age of 40 years or older (E5, E16, C1, E1, E2, E6). The only city council district with a median age below 30 is District 2 at 28.2. Tract E3, home to the University of Utah, has the lowest median age at 22.1 years, followed by tracts W5 and W7 west of I-15.

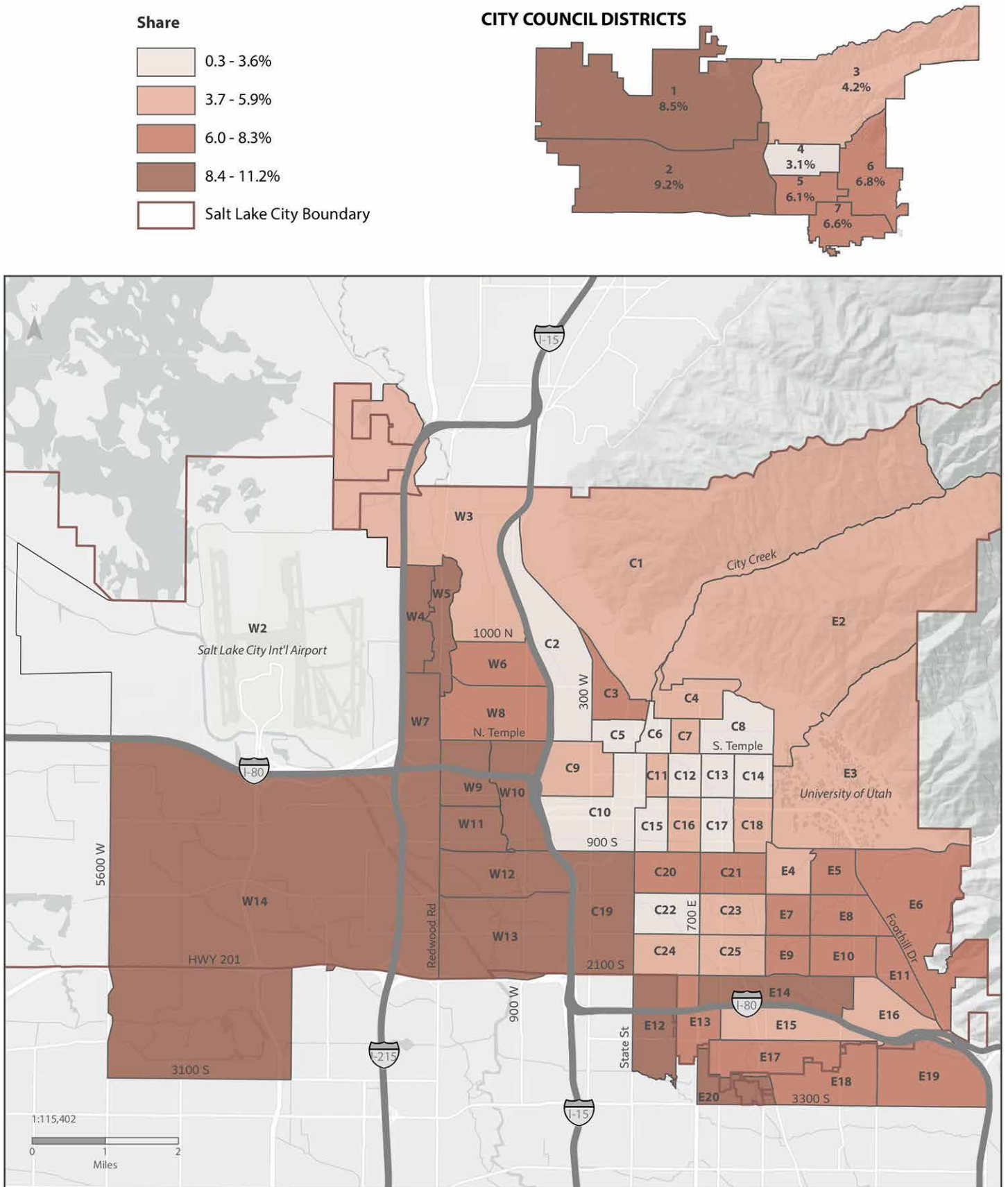

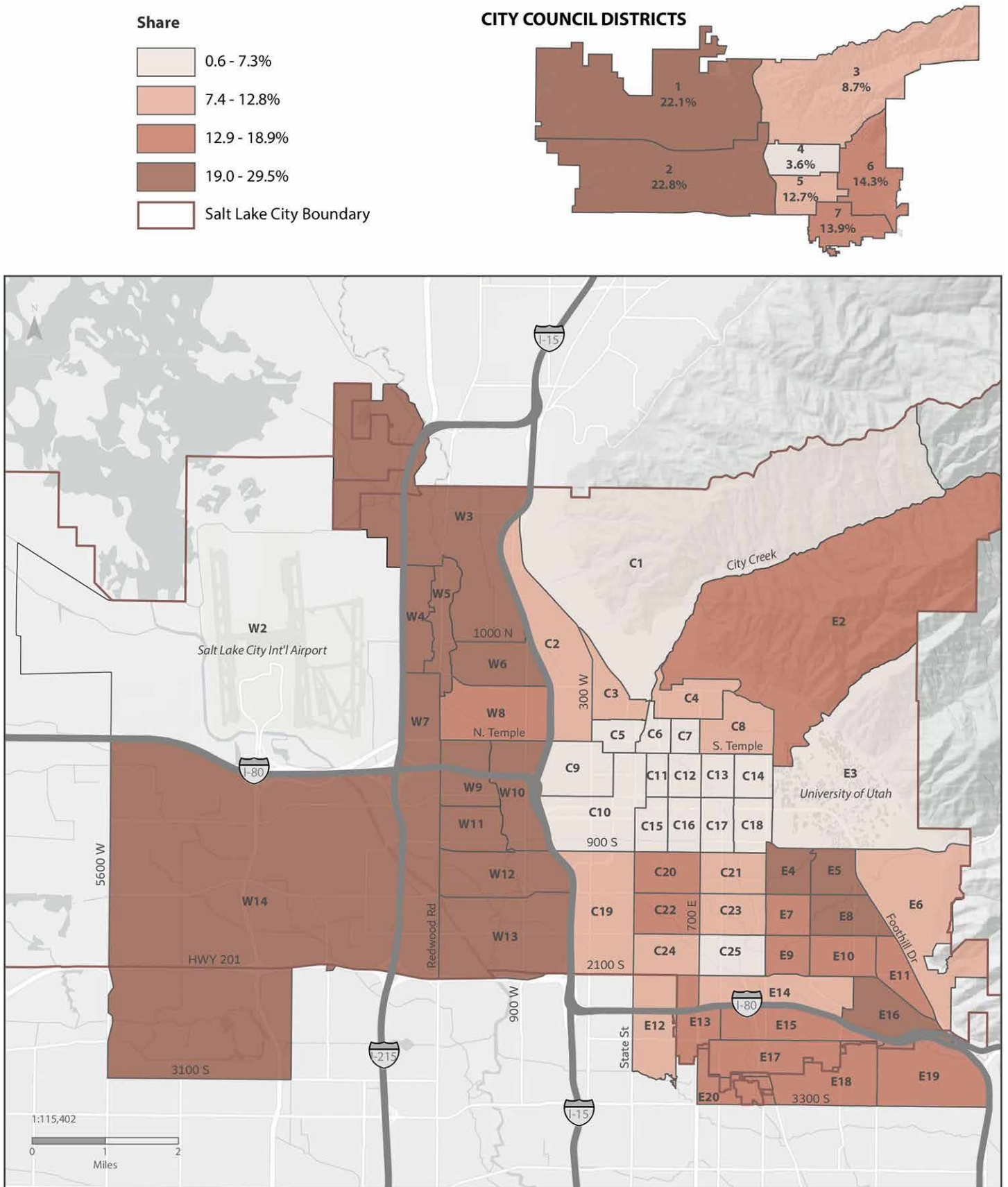

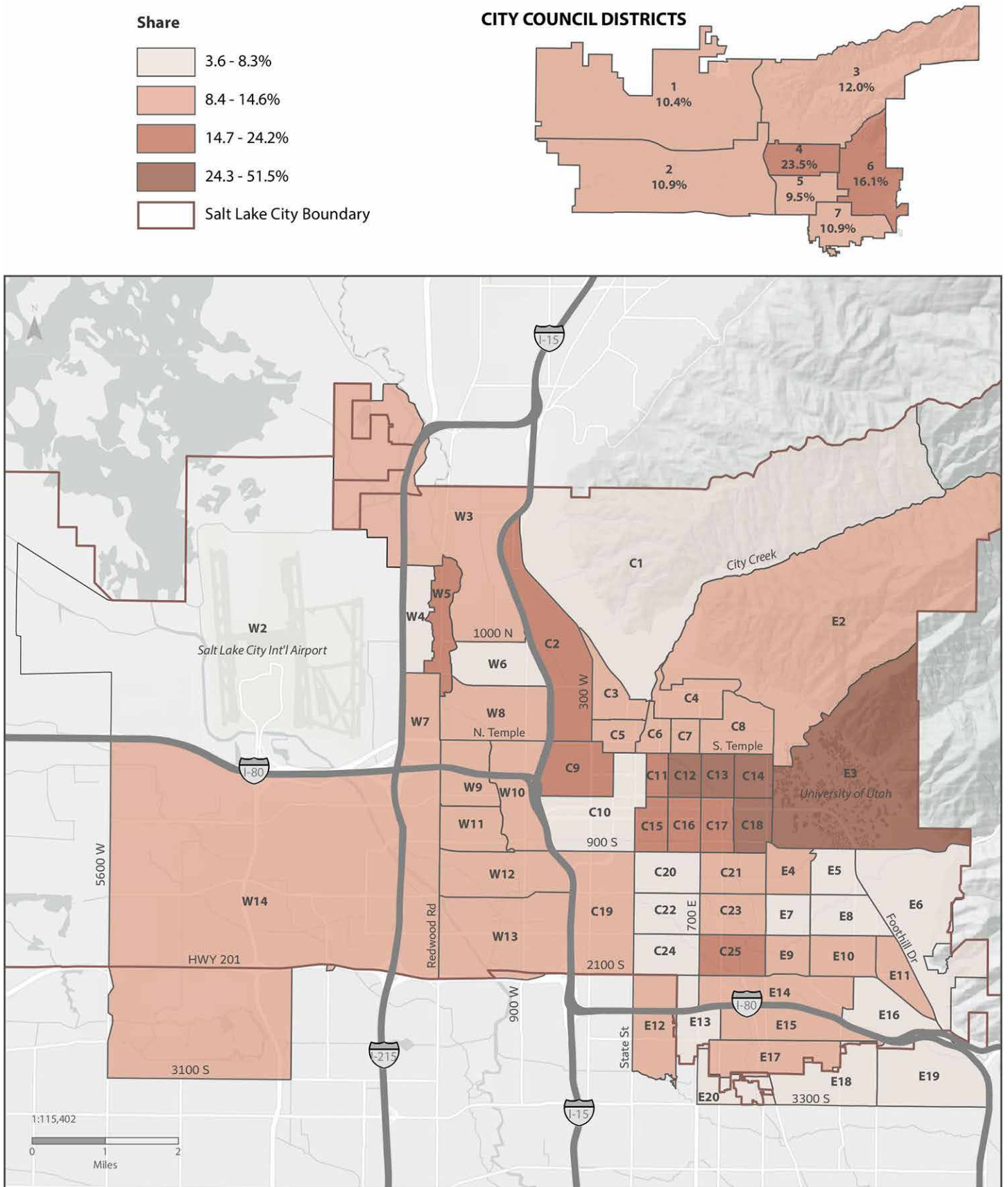

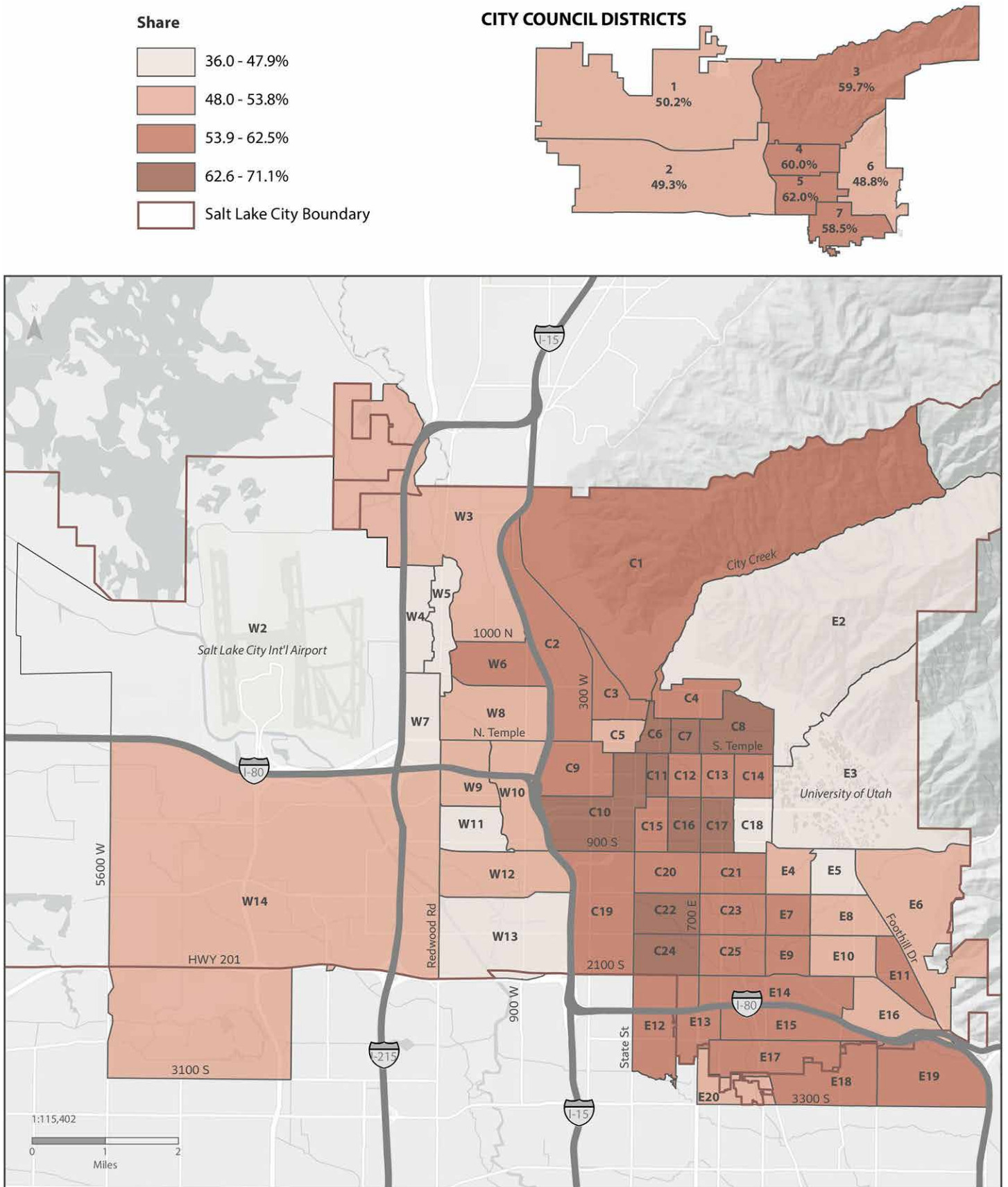

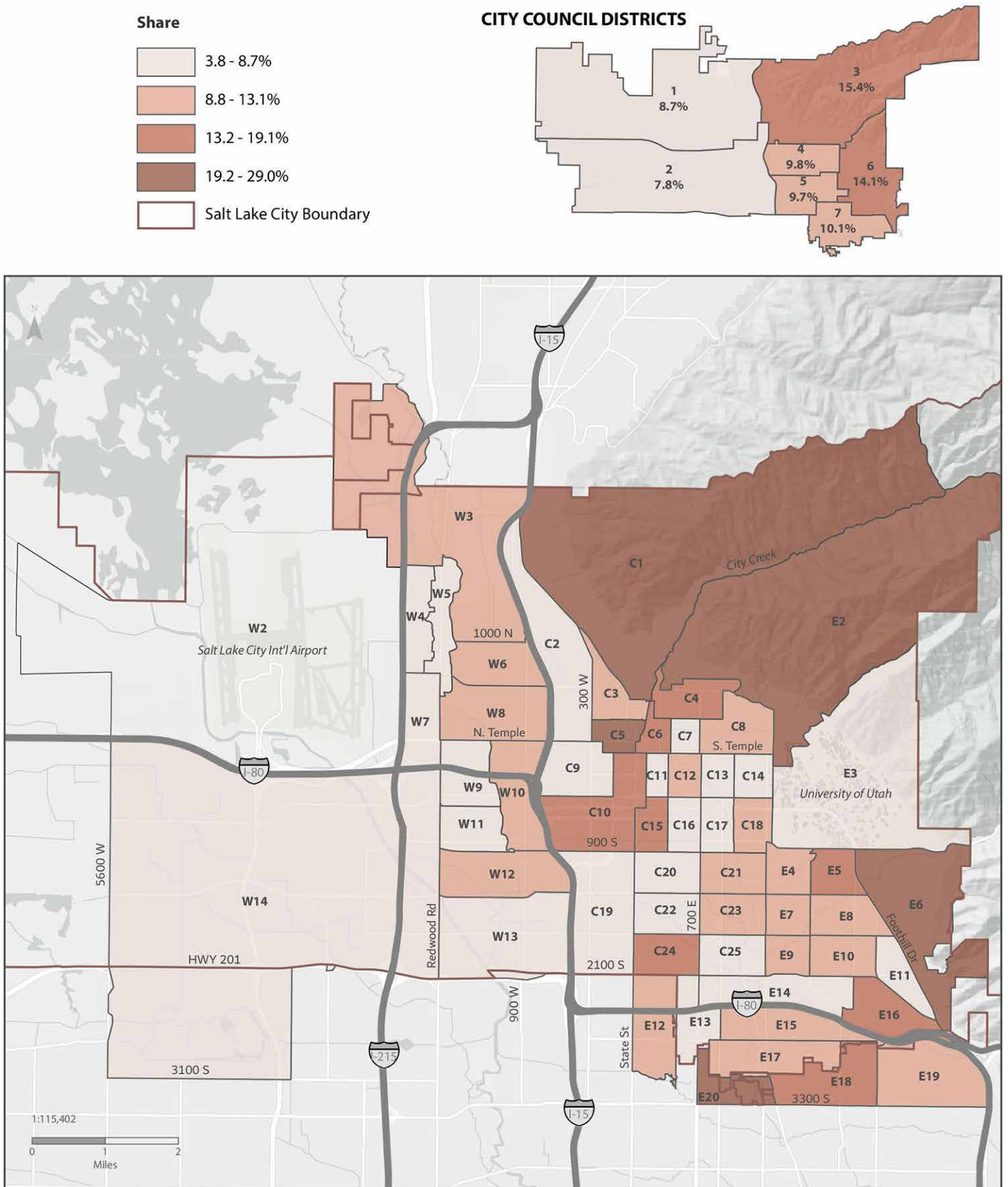

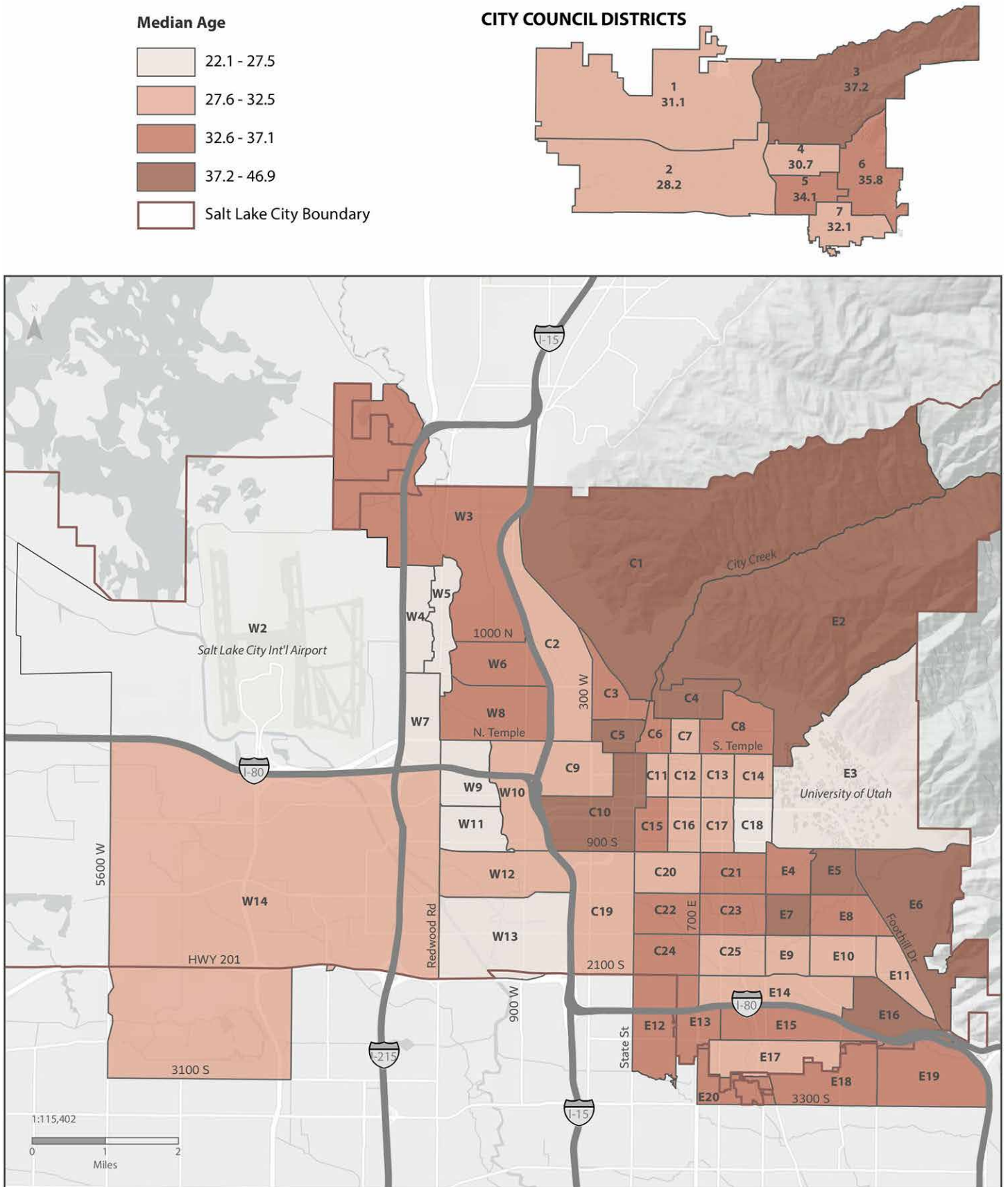

# Households

Salt Lake City has the highest share of nonfamily households of cities in the state and the third-lowest share of households with children under 18 (behind Kanab and Escalante). With the consideration of the high share of college-age and working-age populations in the central neighborhoods of Salt Lake City, this makes sense. The households in central areas of the city reflect these populations through the highest shares of nonfamily households and those living alone. Families, from single-parent to large households, are more likely on the west side of the city. The neighborhoods with older residents are along the eastern edge of the city.

## **Average household size**

Utah has the largest household size in the nation at 3.13 people per household. Salt Lake City is closer to the national average household size (2.63) than Utah's, at 2.43 persons per household (pph). Households west of I-15, in City Council Districts 1 (3.22) and 2 (3.45), were the largest in the city. City Council District 4, in the center of the city, has the smallest households at 1.76 pph. In smaller geographic terms, the largest average households in the city are in tract W4, at 4.05 pph.

## **Households with persons under 18 and over 60**

Salt Lake City has a lower share of households with people over age 60 than the state, at 28.2% compared to 31.6%. District 6 has the highest share of these households at 38.5%, while District 4 is the lowest at 21.5%. Eighteen of the 59 tracts that fall partially or entirely within the city have at least one-third of households with someone 60 or older. Over half of households have someone over 60 in two tracts, E2 and E6.

While 41.3% of Utah households have at least one child (someone under age 18), only one-quarter of Salt Lake City households have at least one child. City Council Districts 1 and 2 both have over 40% of households with a child, while City Council District 4 only has 8%. Households with children are especially common west of I-15, where nine of the fourteen tracts west of I-15 have 40% or more of households with a child.

## **Family households**

Nearly three-quarters of Utah households are family households. In Salt Lake City, just over half of households are family households. At least 70% of households in City Council Districts 1, 2, and 6 are family households. Only one-quarter of households in City Council District 4 are family households. Four tracts (W4, W9, E2, and W13) have 81% or more of households filled with families. Three tracts (C15, C11, and C12) have families in fewer than 20% of households.

While a stereotype of Utah households is large nuclear families with children, only 32.3% of Utah households are married-family with children. The share in Salt Lake City is half that (16.7%). One-third or more of households in three tracts (W4, W14, and E8) are married couples with children. Eight tracts in the central part of the city have 5% or fewer family households with children.

Statewide, 8.7% of households are single-parent households. The share is slightly higher in Salt Lake County (9.6%) but lower in Salt Lake City (8.1%). In City Council Districts 1 and 2, the share is more than double the city's share, at 16.8% and 19.7%, respectively. City Council District 4 is the lowest at 3.8%. In five tracts west of I-15 (W11, W10, W5, W9, and W4), at least one in five households are single parent-led.

## **Nonfamily households**

Statewide, one in four households is a nonfamily household, which includes any households where members have no family relationship as well as those who live alone. In Salt Lake City, nearly half of households are nonfamily, the highest of all cities throughout the state.<sup>7</sup> City Council District 4 stands out, where three-quarters of households have nonfamily arrangements. Over half of the households in Districts 3 and 5 are nonfamily. Tract C12 has the highest share of nonfamily households citywide at 89.2%. On the low end, Tracts W4, W9, and E2 are all in the 12% range.

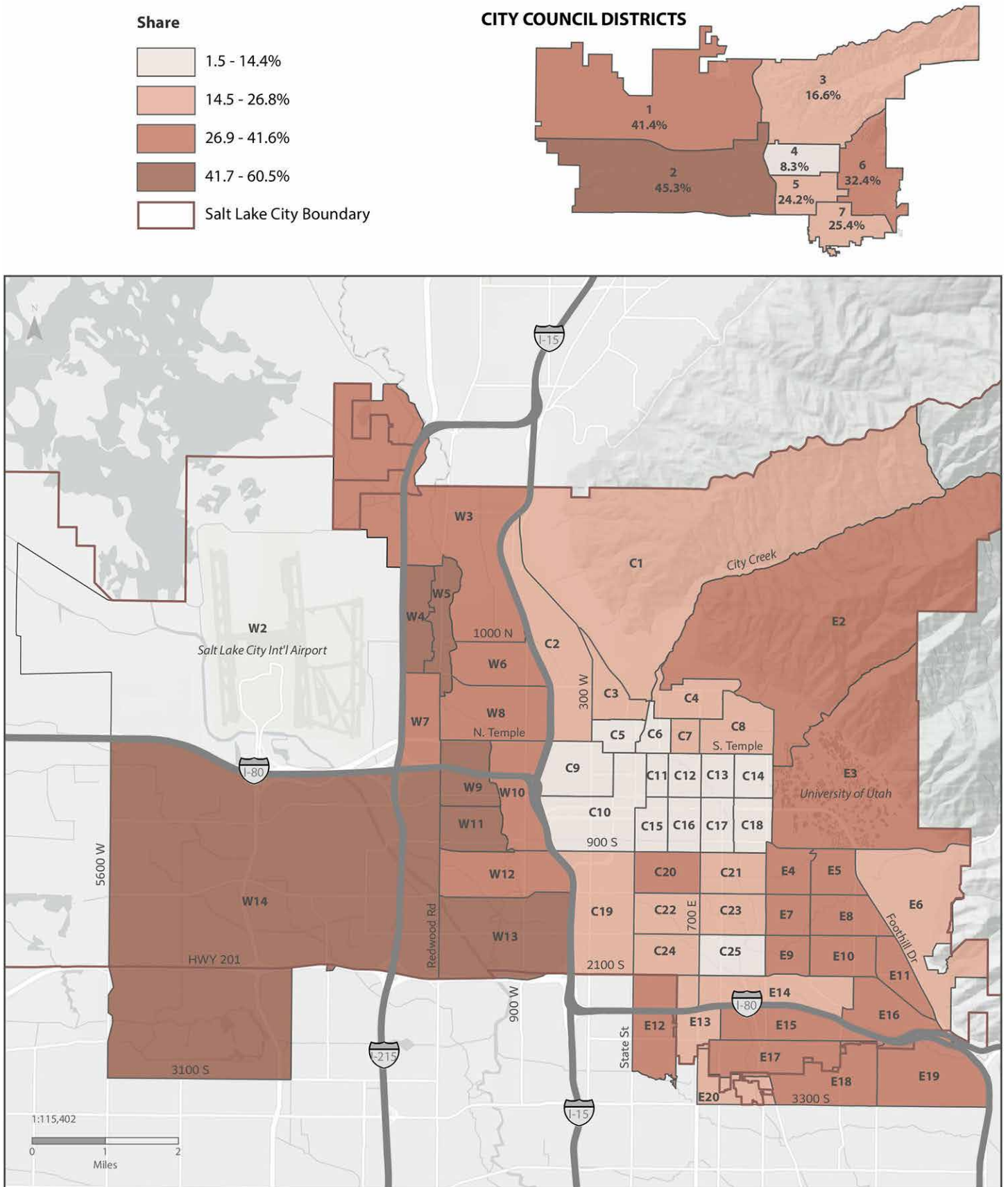

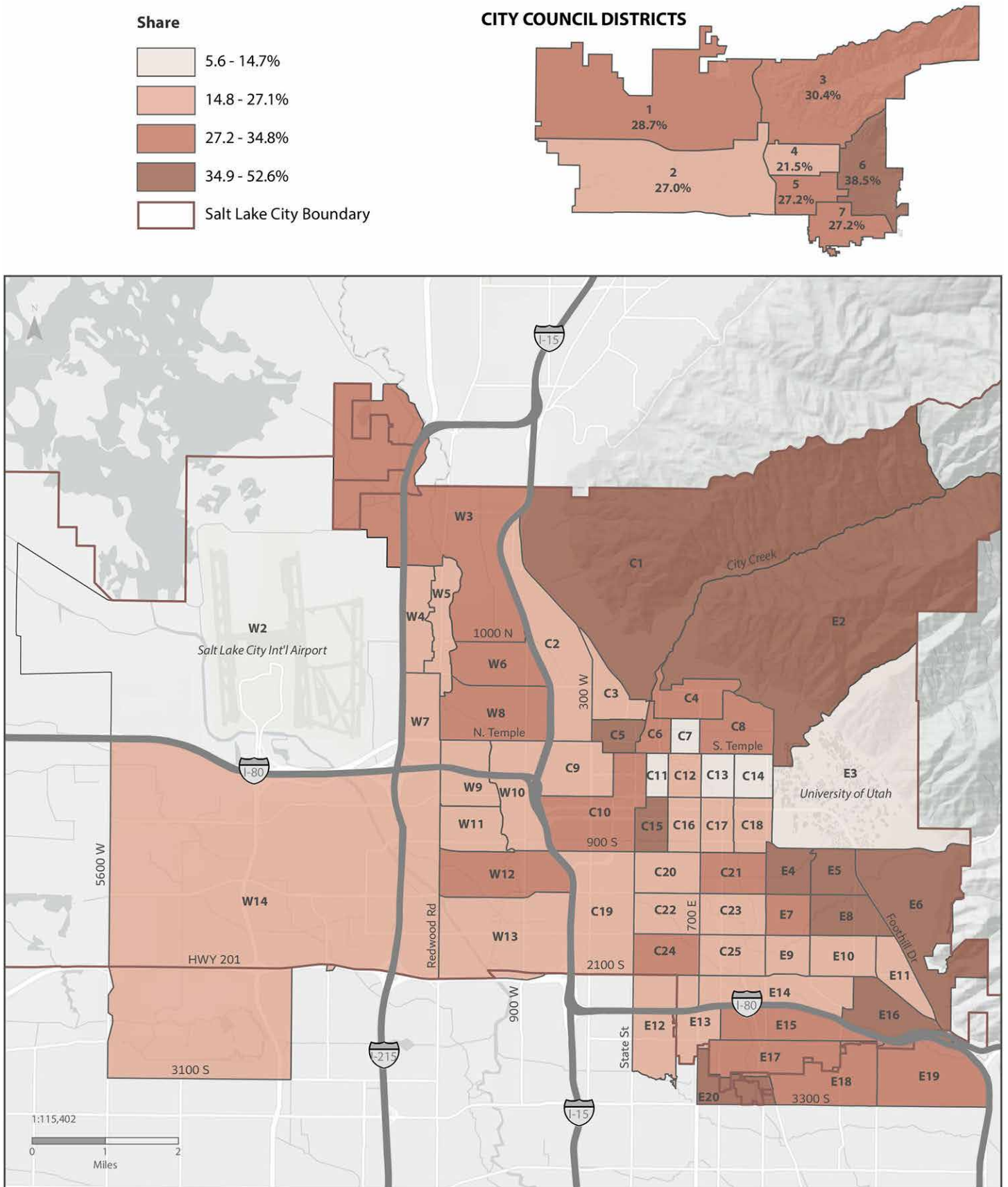

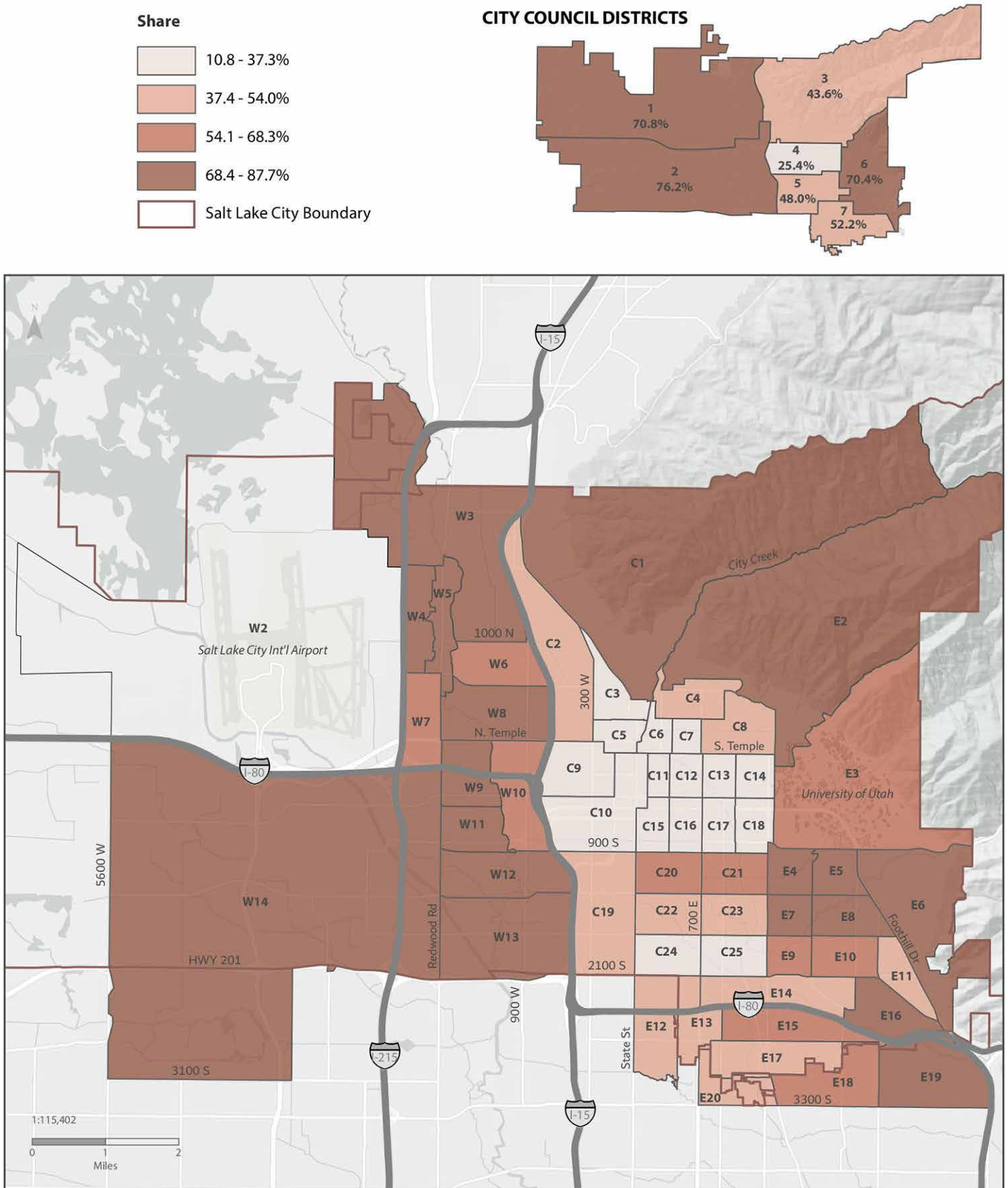

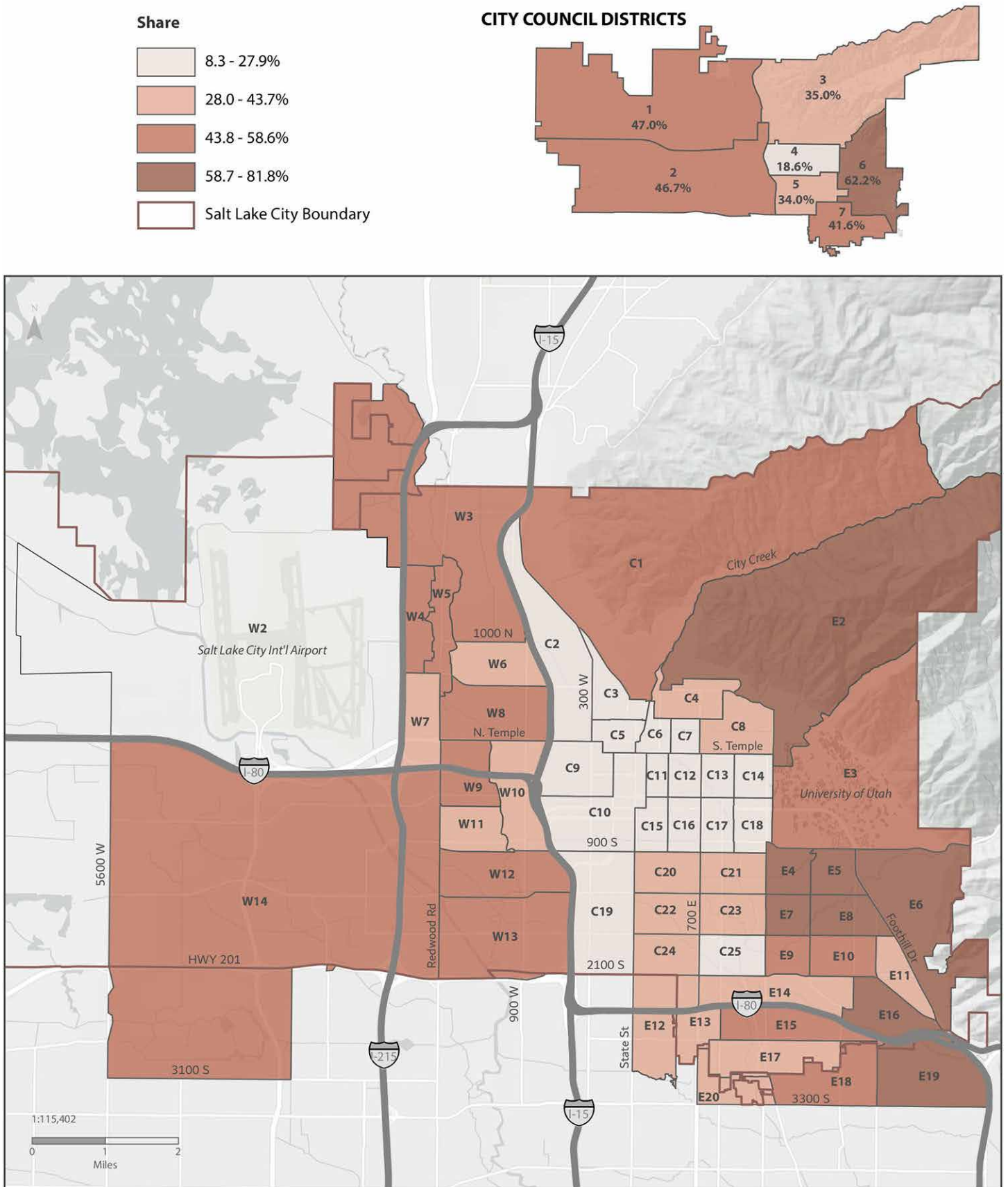

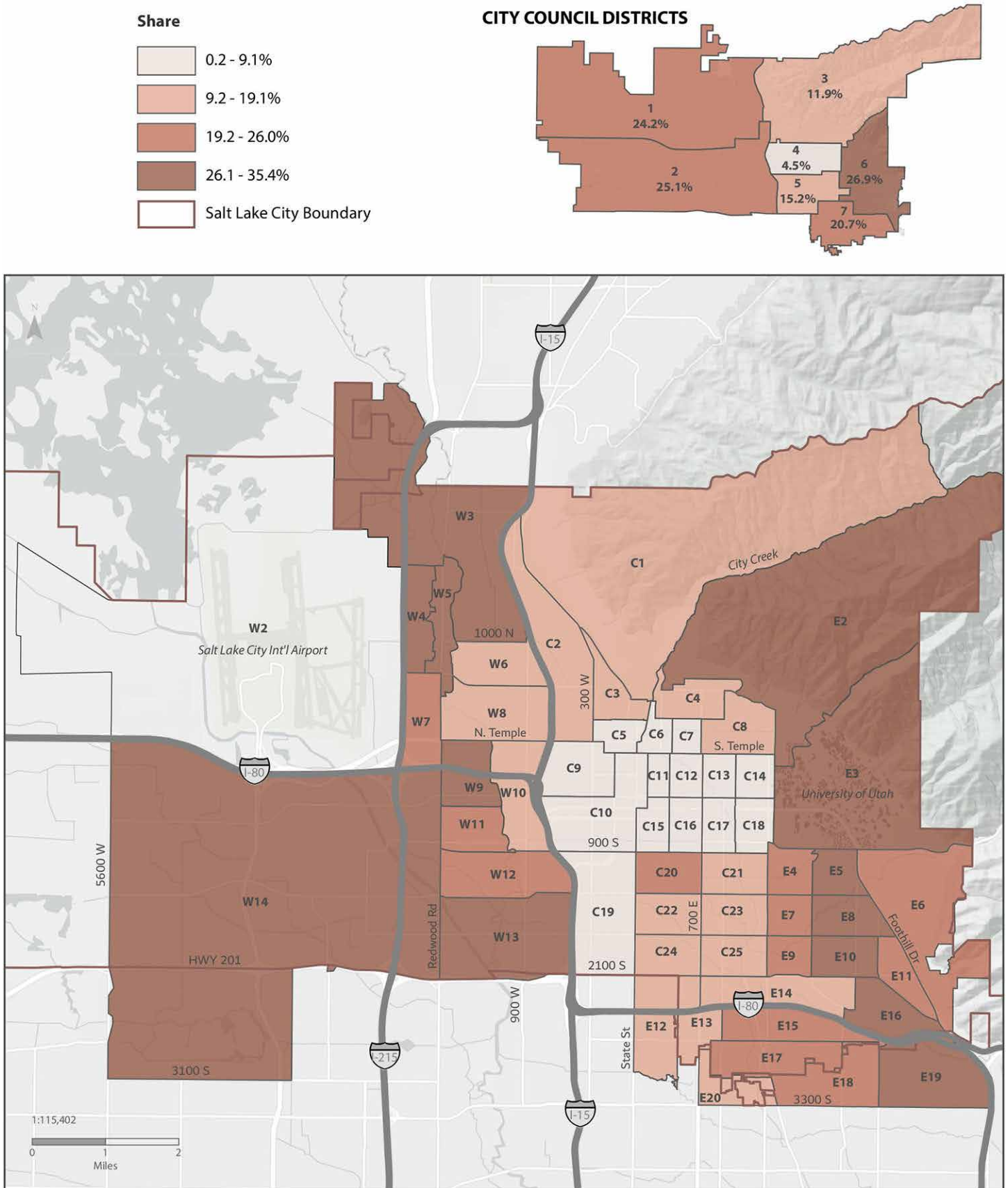

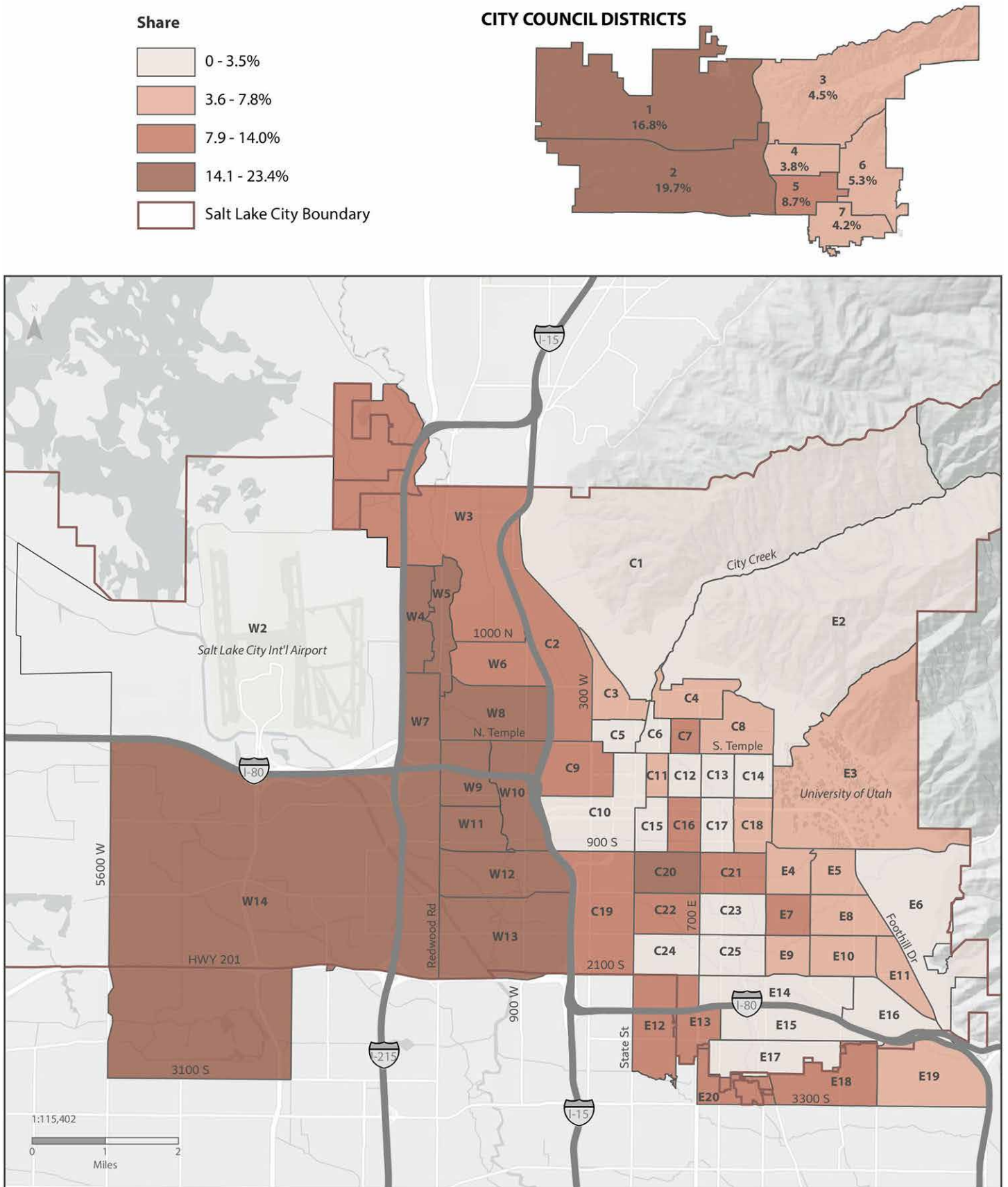

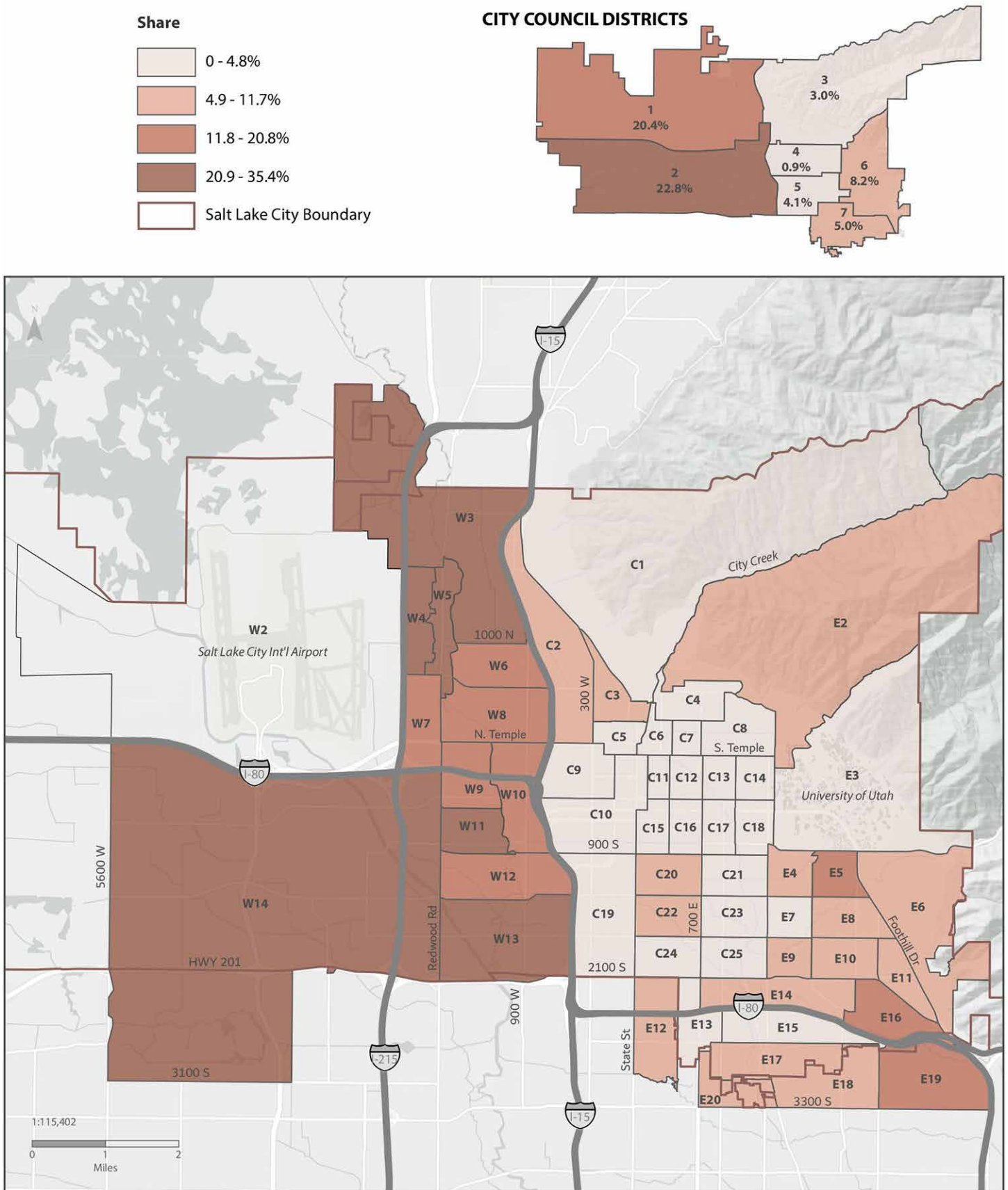

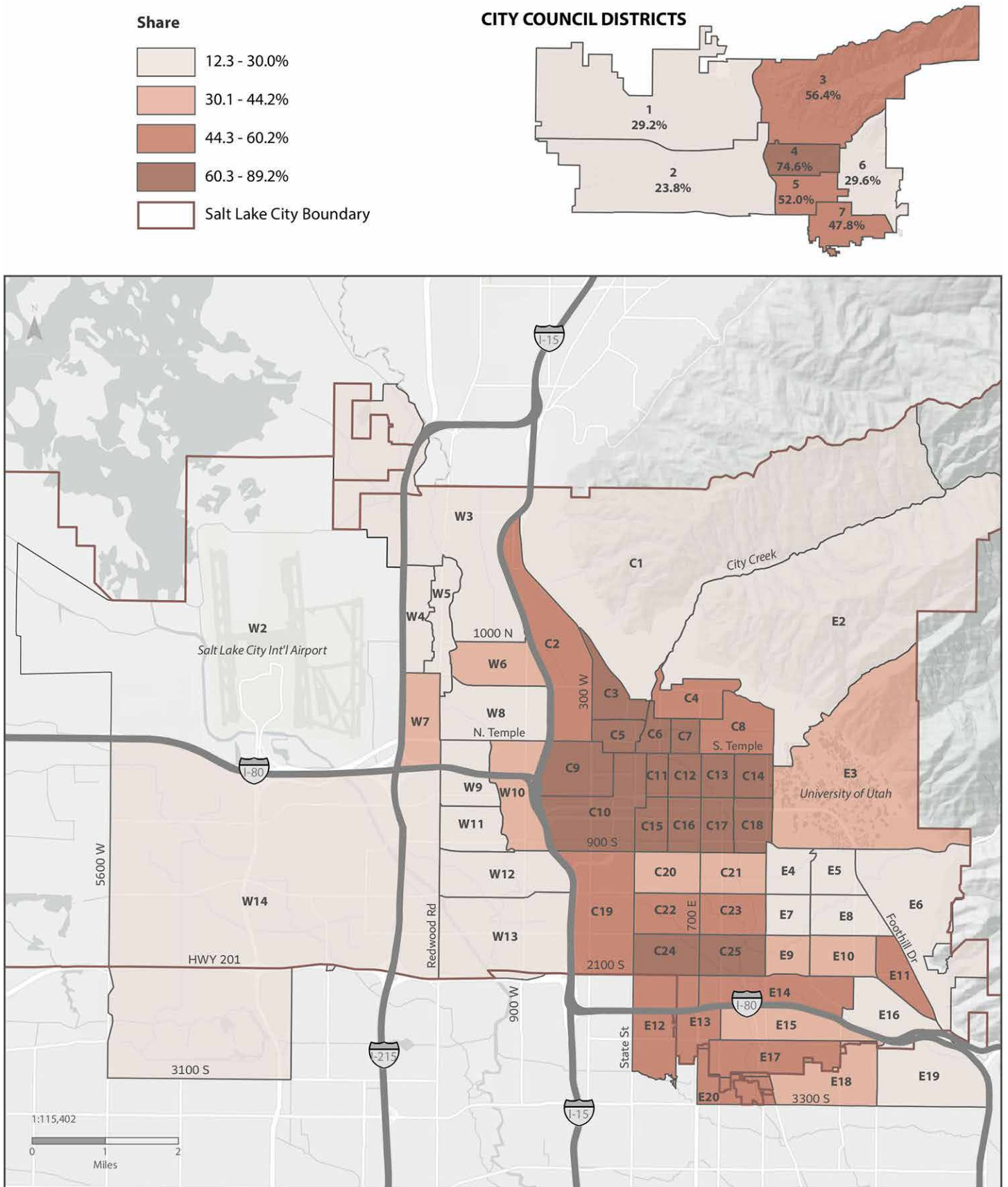

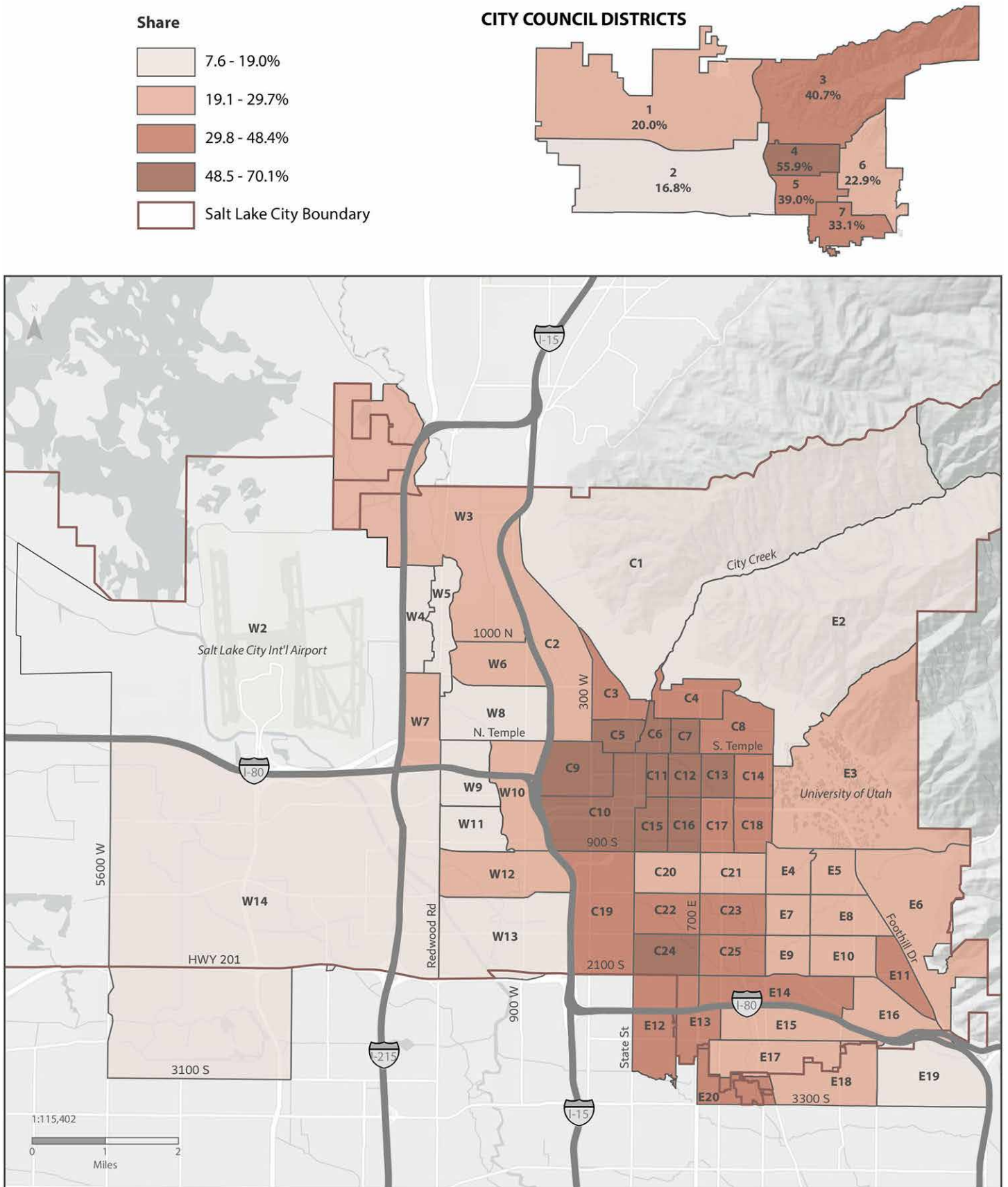

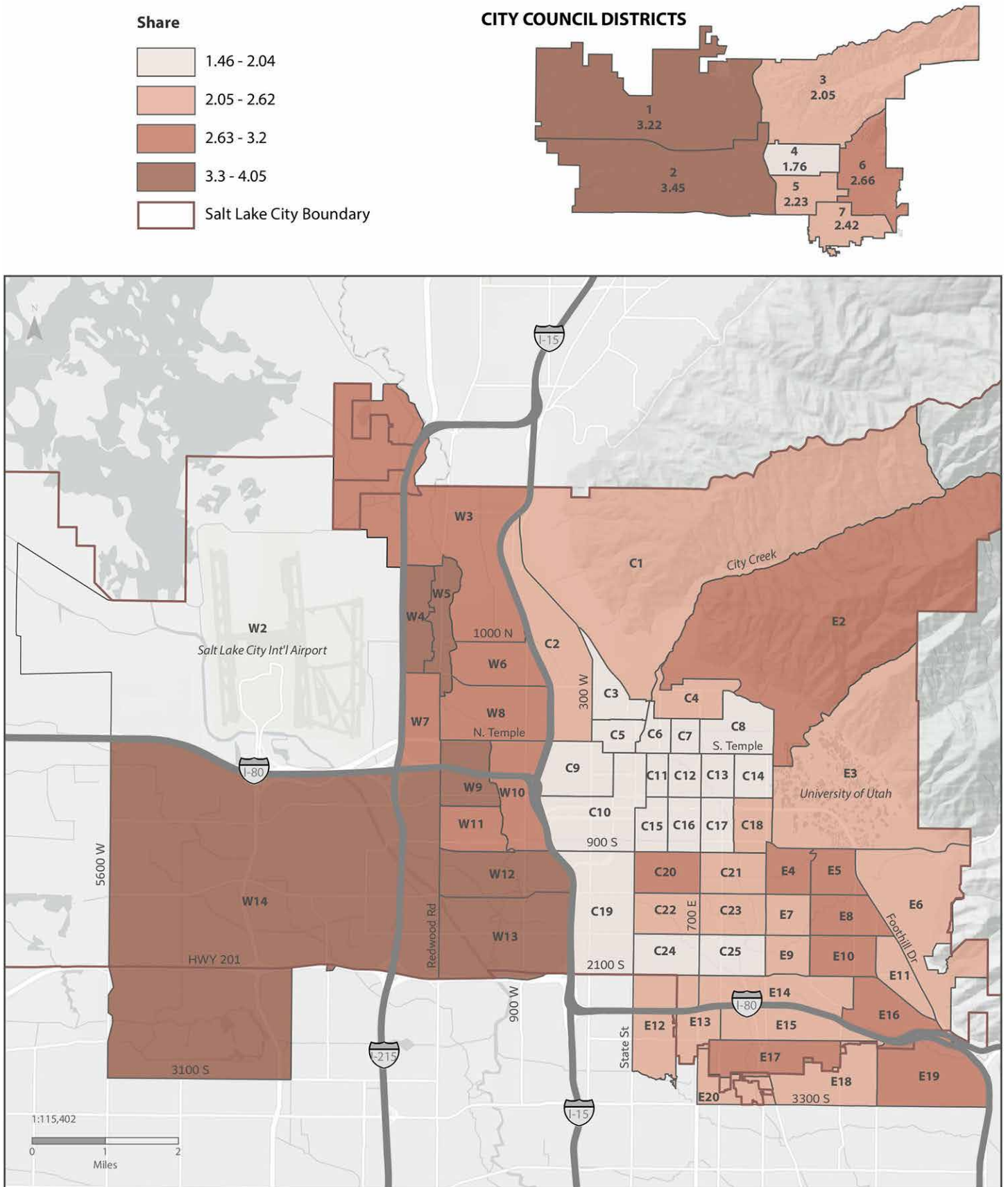

As the state capital and home to the state's flagship university, Salt Lake City has interesting socioeconomic dynamics. For instance, despite having higher educational attainment for adult residents than the state, Salt Lake City has a higher share of households with incomes below the poverty level and a lower median income. The wide variation across city council districts lends itself to an answer for this. A range of about \$60,000 separates the highest median income district from the lowest. The share of adults with a Bachelor's degree or higher ranges from 13.5% to 71.9% across the seven districts. The city also has a higher share of residents with geographic mobility than the state. A larger share of Salt Lake City residents are foreign-born or have moved from within or outside Utah than for the state as a whole.

## ***Income and Poverty***

In Salt Lake City, 15.9% of households had incomes below the poverty level. This share of households is higher than the state (10.1%) and the county (9.3%).<sup>8</sup> City Council District 4 had the highest share of households in poverty (22.4%), followed closely by District 1 (21.0%) and District 2 (20.2%). District 6 had the lowest share of households in poverty (9%). The tract that includes the University of Utah campus had the highest poverty rate, with seven additional tracts in the central and western parts of the city having at least 25% of households below poverty.

The median household income in Salt Lake City was \$56,370, lower than both the state (\$68,374) and the county (\$71,230).<sup>9</sup> Within the city, the difference between the highest and lowest household median incomes by City Council District was about \$60,000. City Council District 6 has the highest median household income at \$101,465, while City Council District 4 has the lowest at just over \$41,192.

## ***Educational Attainment of the Population Aged 25 Years and Over***

The share of those with a Bachelor's degree or higher in Salt Lake City is 45.1%. This share is over ten percentage points higher than the shares at the state (33.3%) and county (34.5%) levels.<sup>10</sup> Four City Council Districts have over half of their population with Bachelor's or higher (4, 7, 3, and 6) with District 3 at 63.1% and District 6 at 71.9%. For the remaining three districts, two have less than 20% of residents 25 or older with a

Bachelor's or higher (District 2 at 13.5% and District 1 at 17.1%). Four tracts on the east (E6, E7, E2, E4) have at least 75% of the population with a Bachelor's degree or more. Three tracts on the west (W1, W13, and W9) had less than 10% of their populations with a Bachelor's degree or more.

While the share of those with secondary education in Salt Lake City is higher than the state and county, the share of those without a high school diploma is also higher. 11.5% of Salt Lake City's residents do not have their high school diploma, while only 8% of Utahns and 9.6% of county residents have the same attainment. City Council Districts 1 and 2 have the highest share of those without a high school diploma (27.7% and 32.9%). Less than 10% of the residents 25 and over in the remaining five districts have this same level of educational attainment. At least one-third of adults living in five west side tracts (W13, W9, W12, W11, and W8) have less than a high school degree.

## ***Foreign-born***

Salt Lake City's foreign-born population accounts for 12.7% of the statewide foreign-born population and 22.9% of the county's foreign-born population. Overall, 16.7% of Salt Lake City's population was born outside the United States. Statewide, only 8.4% of Utahns are foreign-born. City Council Districts 1 (28.8%) and 2 (31.3%) have the highest foreign-born shares, with all other Districts being less than 20%. Eleven tracts have at least one-quarter or more of their populations born outside the US. All of these tracts are west of I-15, with four having more than 30% of their population being foreign-born.

## ***Movers from other states and within Utah***

City Council Districts 3 and 4 had the highest share of movers from other states at 6.5 and 6.7%. City Council District 2 had the lowest at 2.4%. Tract C5 had the highest share of out-of-state movers at one-in-five residents (20.9%).

For those who moved within Utah, City Council District 4 (23.2%) and 3 (17.3%) had the highest shares of in-state movers. City Council District 2 was also the lowest for those moving from within Utah, at 11.6%. Two tracts (C12 and C11) had over 30% moving from within Utah. Another five tracts had at least 25% movers from within Utah (E3, C6, C13, C14, and W14)

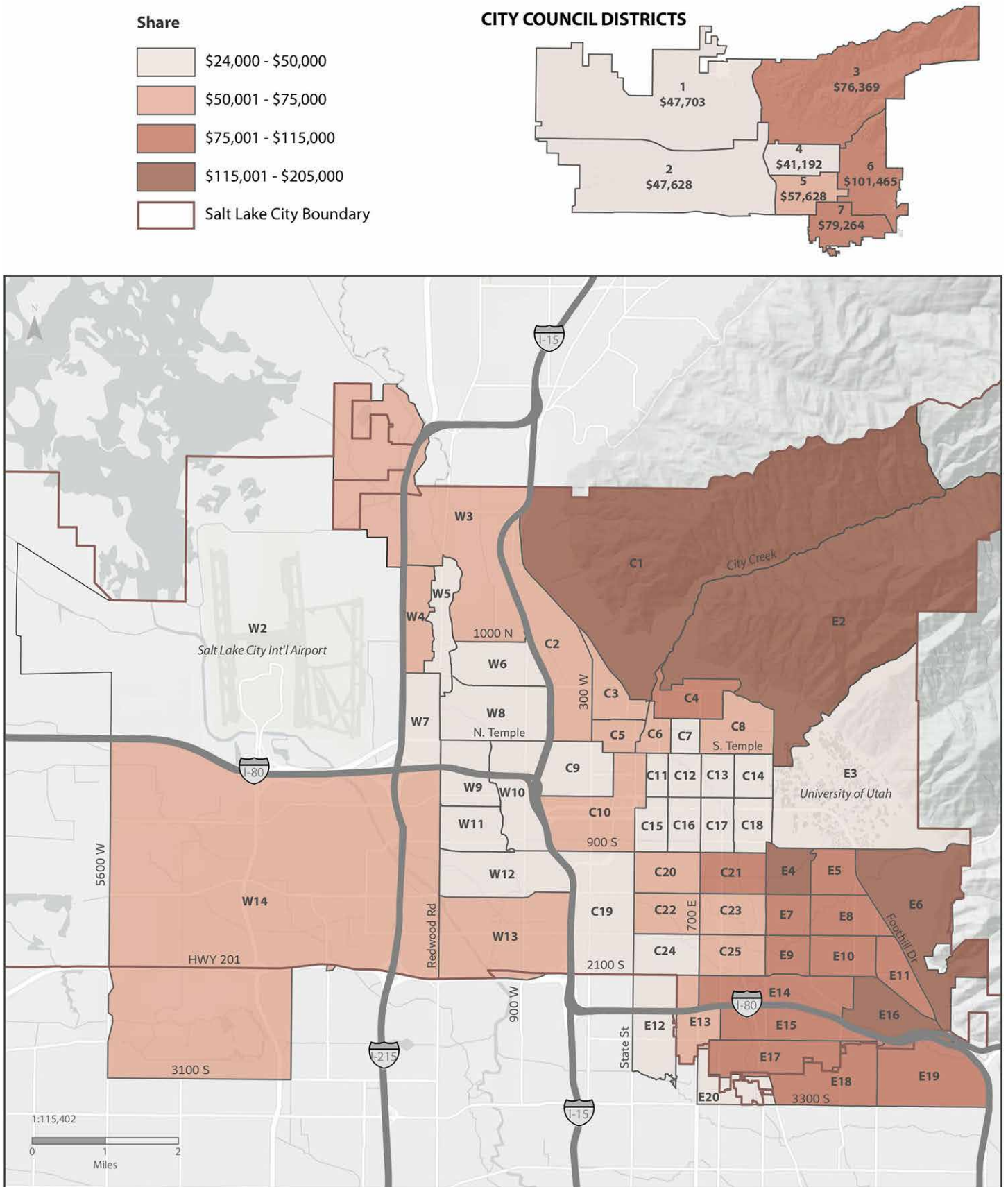

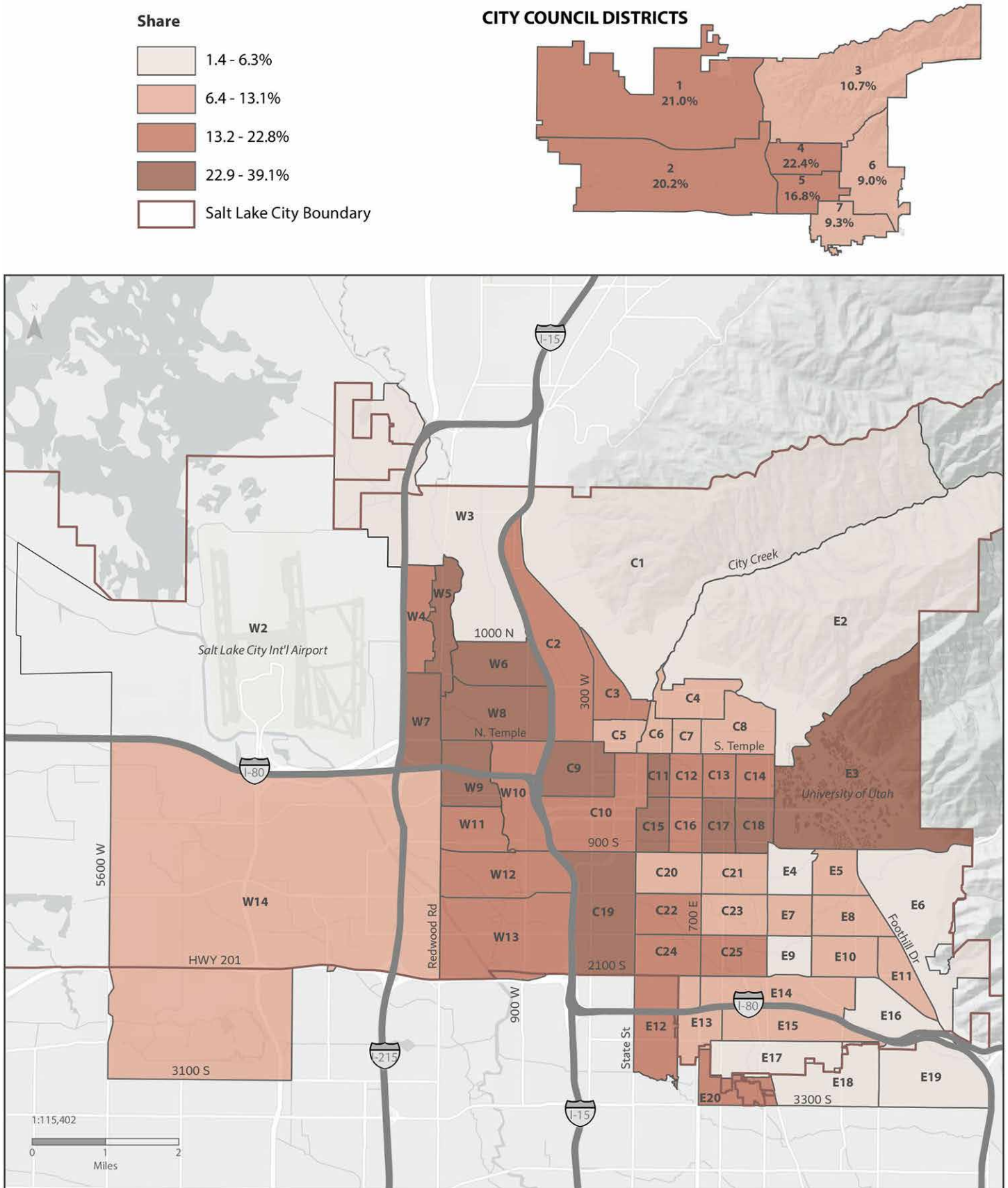

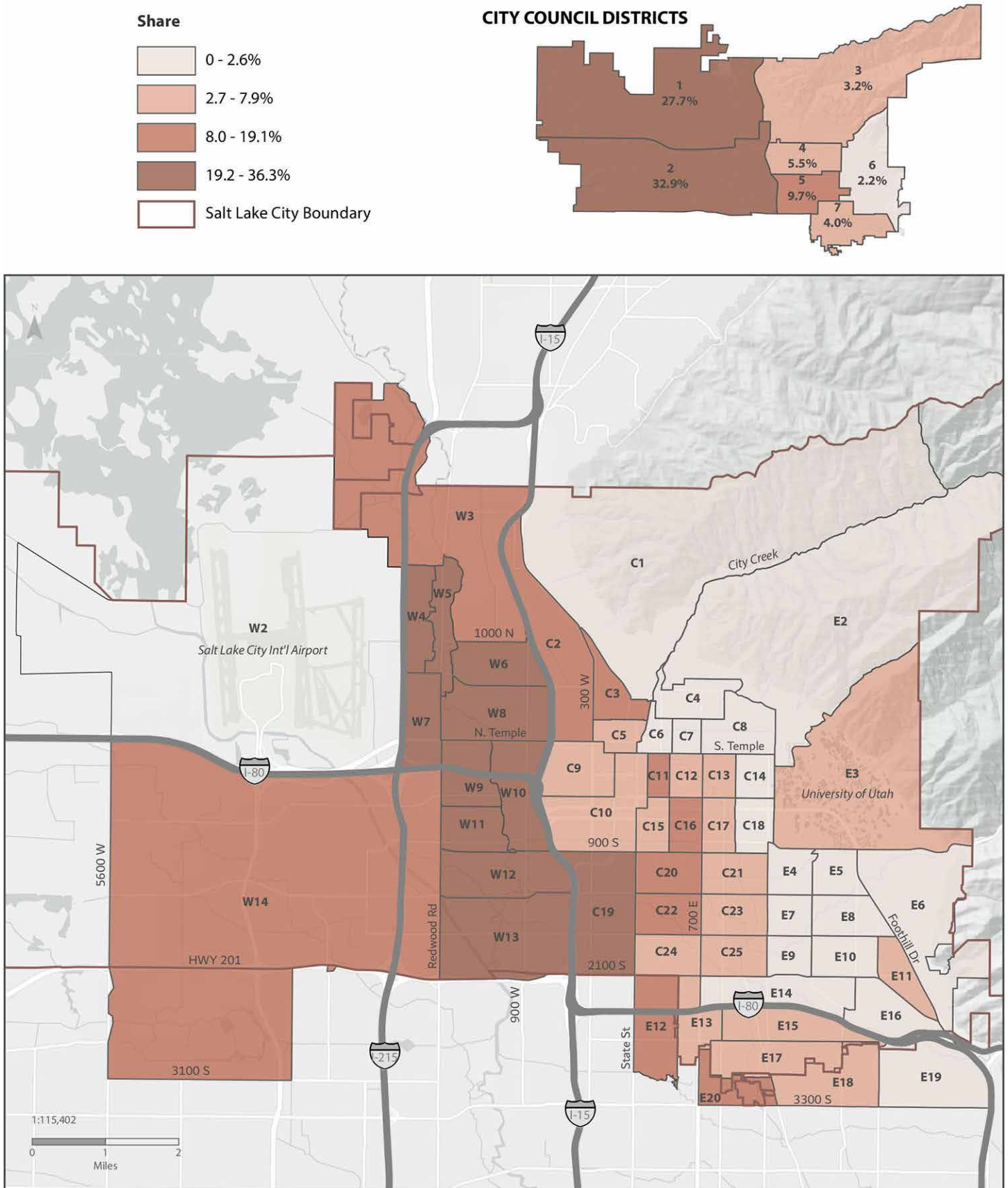

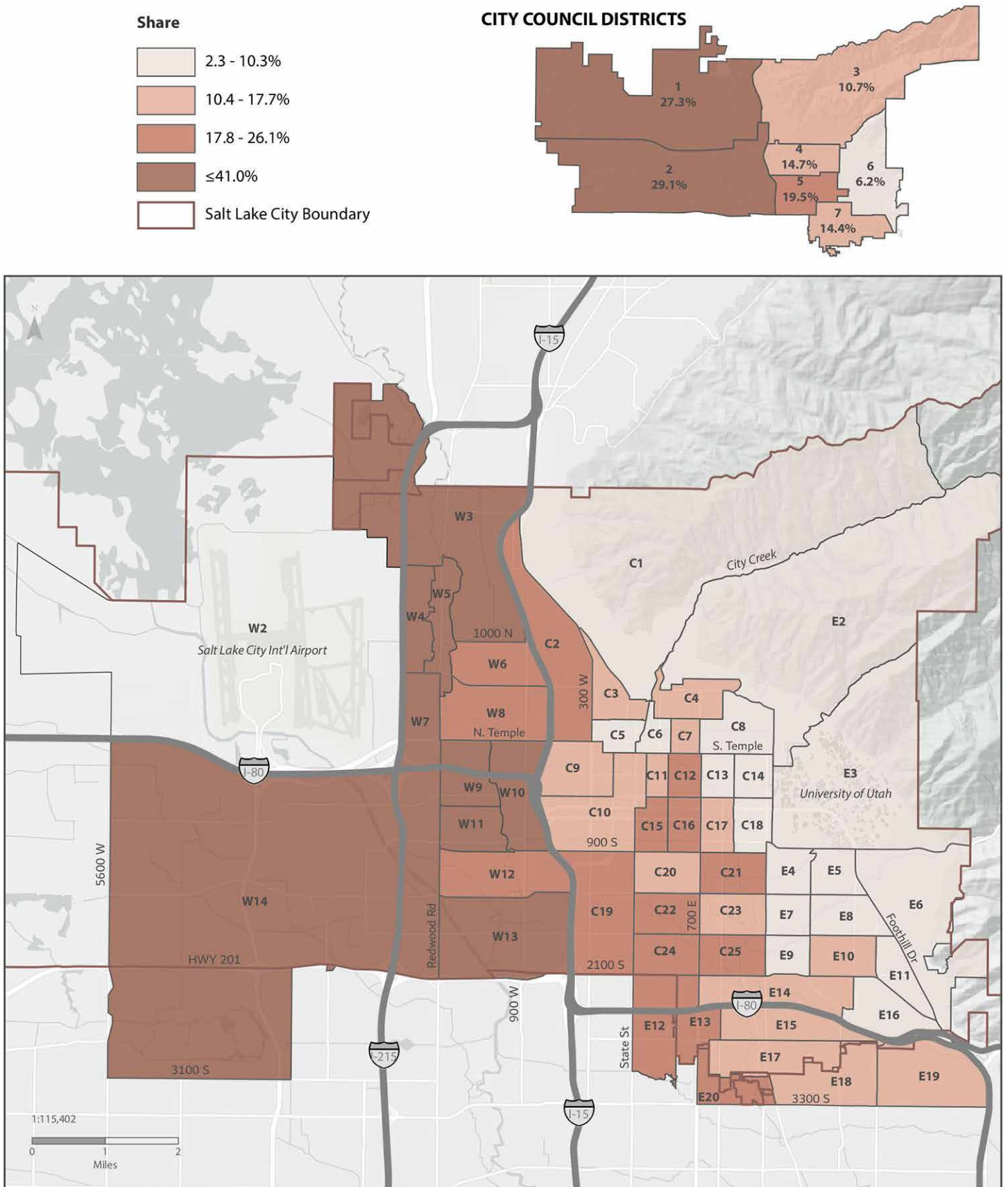

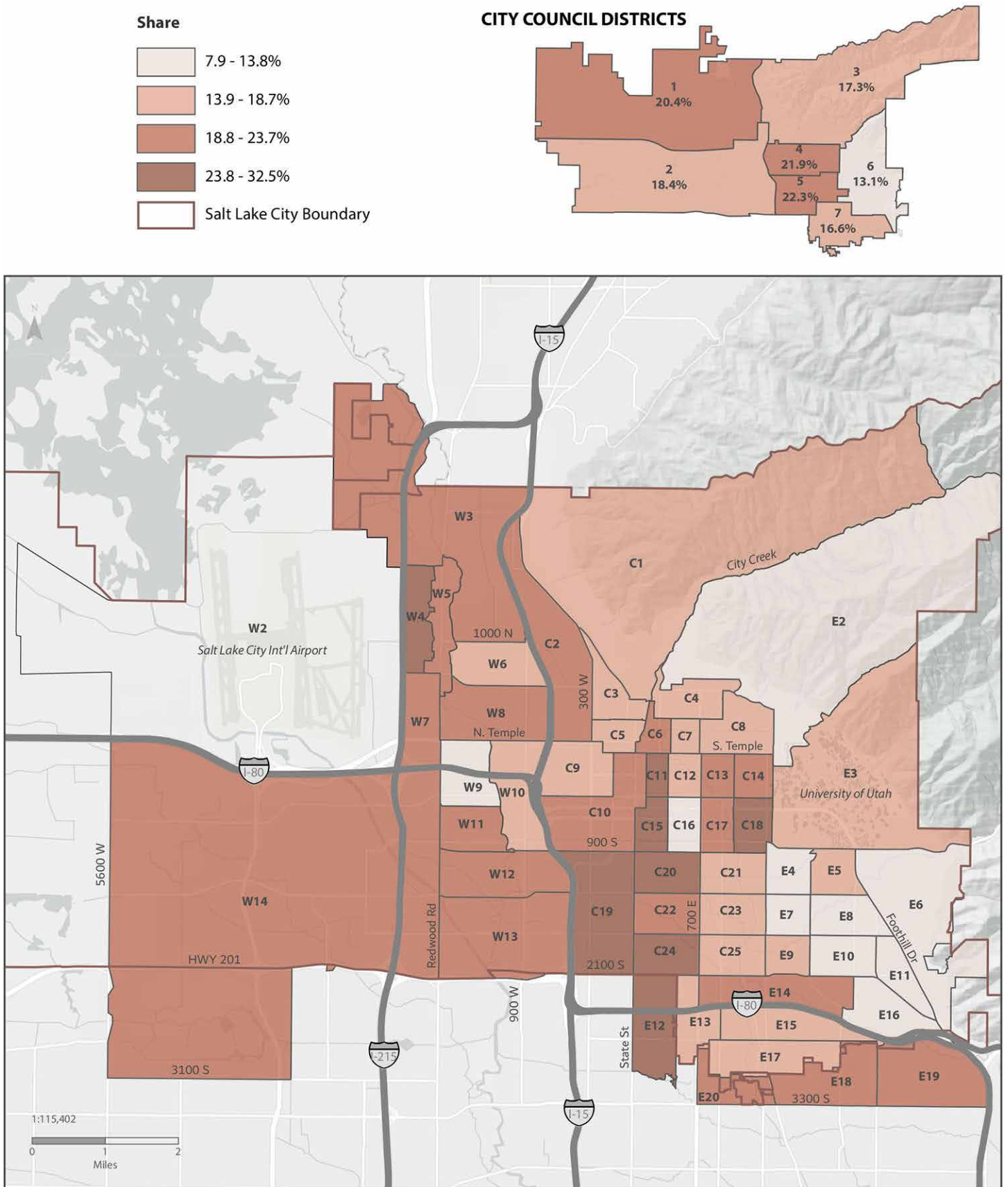

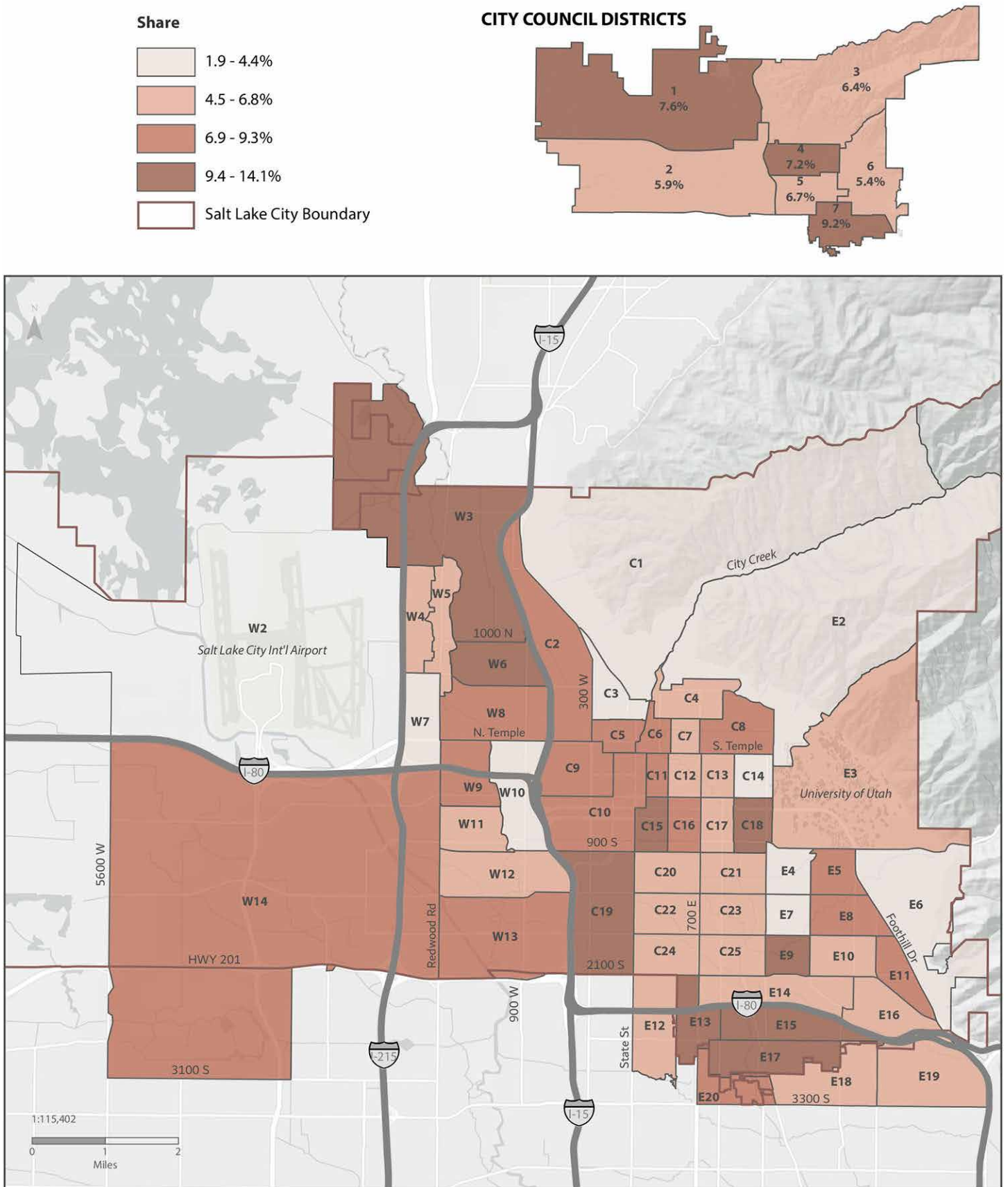

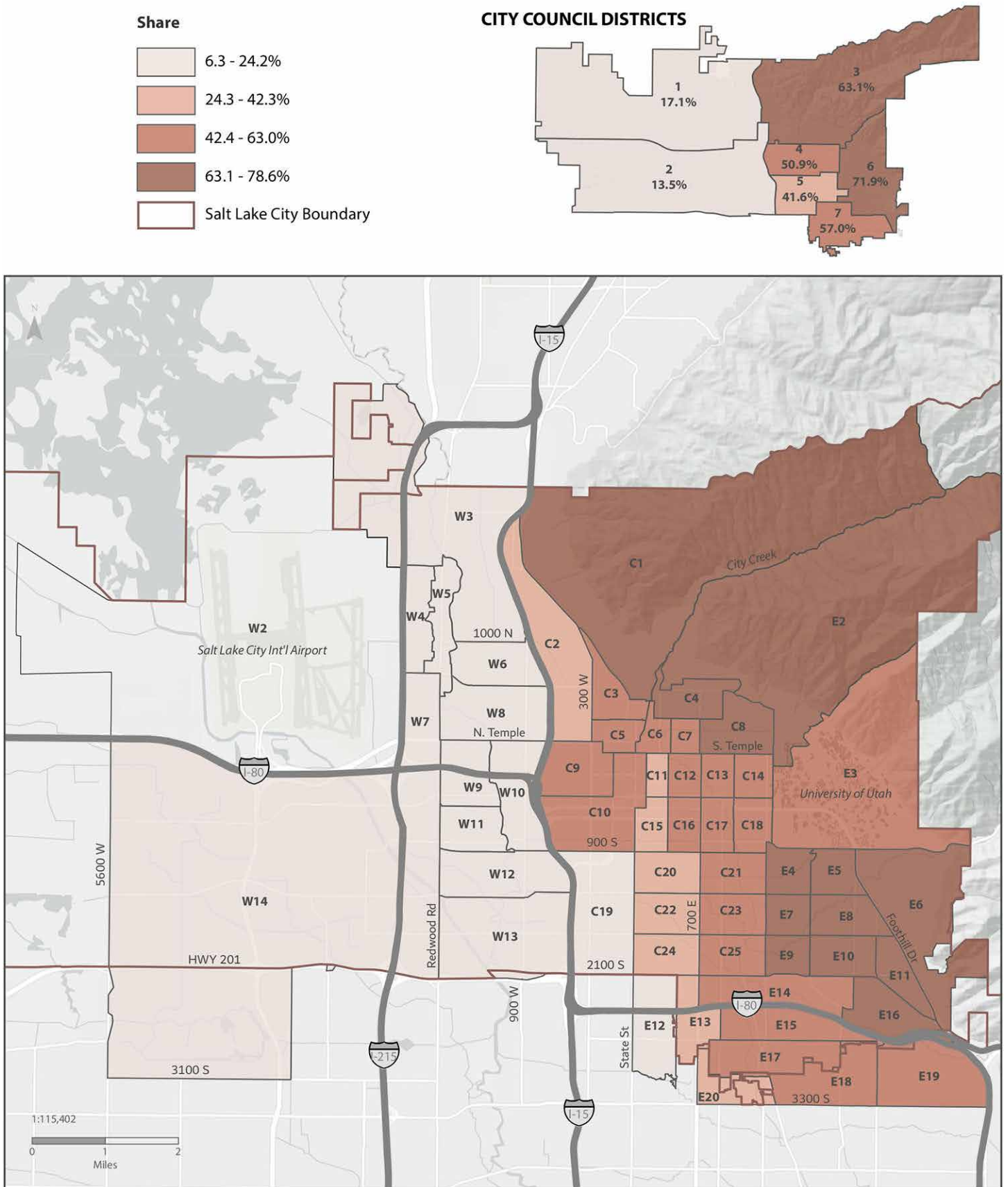

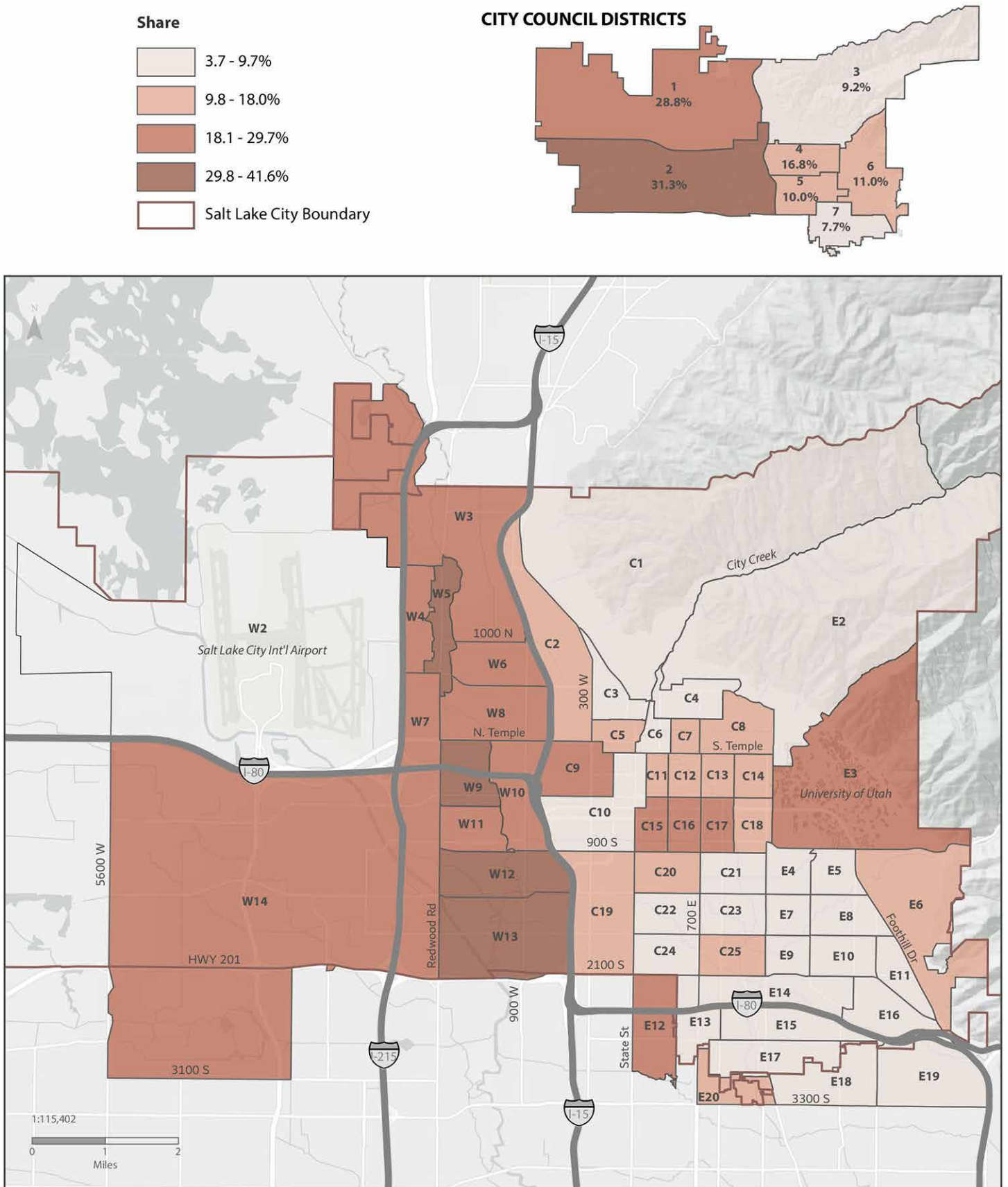

## **American Community Survey**

The American Community Survey (ACS) is an ongoing survey done by the U.S. Census Bureau that provides information on social and economic characteristics of communities. The ACS began in 2008 and replaced the Census Long Form in 2010. ACS data are available on an annual basis for populations over 65,000 and every five years for all geographies with lower populations.

The data provided by the ACS is based upon a sample rather than a full count of the population and thus also “reflect data that have been collected over a period of time rather than for a single point in time as in the decennial census...”.<sup>11</sup> This, combined with small sample sizes at the tract level, can create large margins of error and can make the data less reliable.

The ACS estimates of population and households provide the denominators for the shares given for all ACS data sections of this atlas (all sections except the Subcounty Population and Household Estimates section). For example, the share of population age 65 and older in 2014-2018 in a census tract is calculated out of the estimated 2014-2018 total population for the tract. These denominators are shared in the following pages as a reference point. The maps display the total population and total household estimates for this time period. Note that the estimates in the Subcounty Population and Household Estimates section are point-in-time estimates that do not relate to the five-year ACS data, and should not be used to calculate shares for any ACS estimates.

## **ACS Data Analysis and Aggregation**

We analyzed the 5-year 2014-2018 ACS dataset. Census tract and city level data are available in each dataset. City council districts for Salt Lake City are not part of ACS geographies; we aggregated groups of census tracts to approximate ACS estimates and margins of error and other statistical values for each district. See the Geography Notes section for a reference figure displaying which tracts were grouped to each city council district. Data for these approximated city council districts do not sum to city totals.<sup>12</sup>

Though census tract and city data are reported in the ACS, several data topics in this book required us to aggregate multiple estimates to produce desired data topics. For example, multiple age ranges were aggregated to create each age category (under 5, age 5 to 17, age 18 to 24, etc.). We also calculated approximated margins of error and other statistical values for each of these new, aggregated estimates. We followed Census Bureau recommendations in order to aggregate estimates and statistical values across geographic areas and data subcategories.<sup>13</sup>

For this Data Book, a coefficient of variation (CV) is employed to help readers understand the “fitness for use” of the data. Although there are no set levels of fitness or reliability with the CV, smaller values are considered more reliable than higher values. Guidance provided by the Census Bureau also suggests:

“A general guideline when working with ACS estimates is that, while data are available at low geographic levels, in situations where the CVs for these estimates are high, the reliability of the estimates will be improved by aggregating such estimates to a higher geographic level.”<sup>14</sup>

When census tract level data are presented in this document, the data is not further aggregated to reduce high CVs. In 2005, the National Research Center proposed the following thresholds to analyze reliability of ACS data:<sup>15</sup>

- High reliability – less than or equal to 12
- Medium reliability – 13 to 40
- Low reliability – over 40

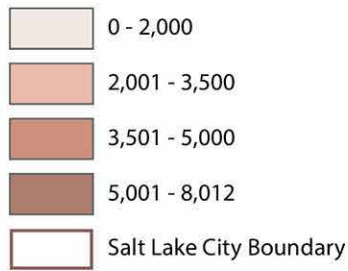

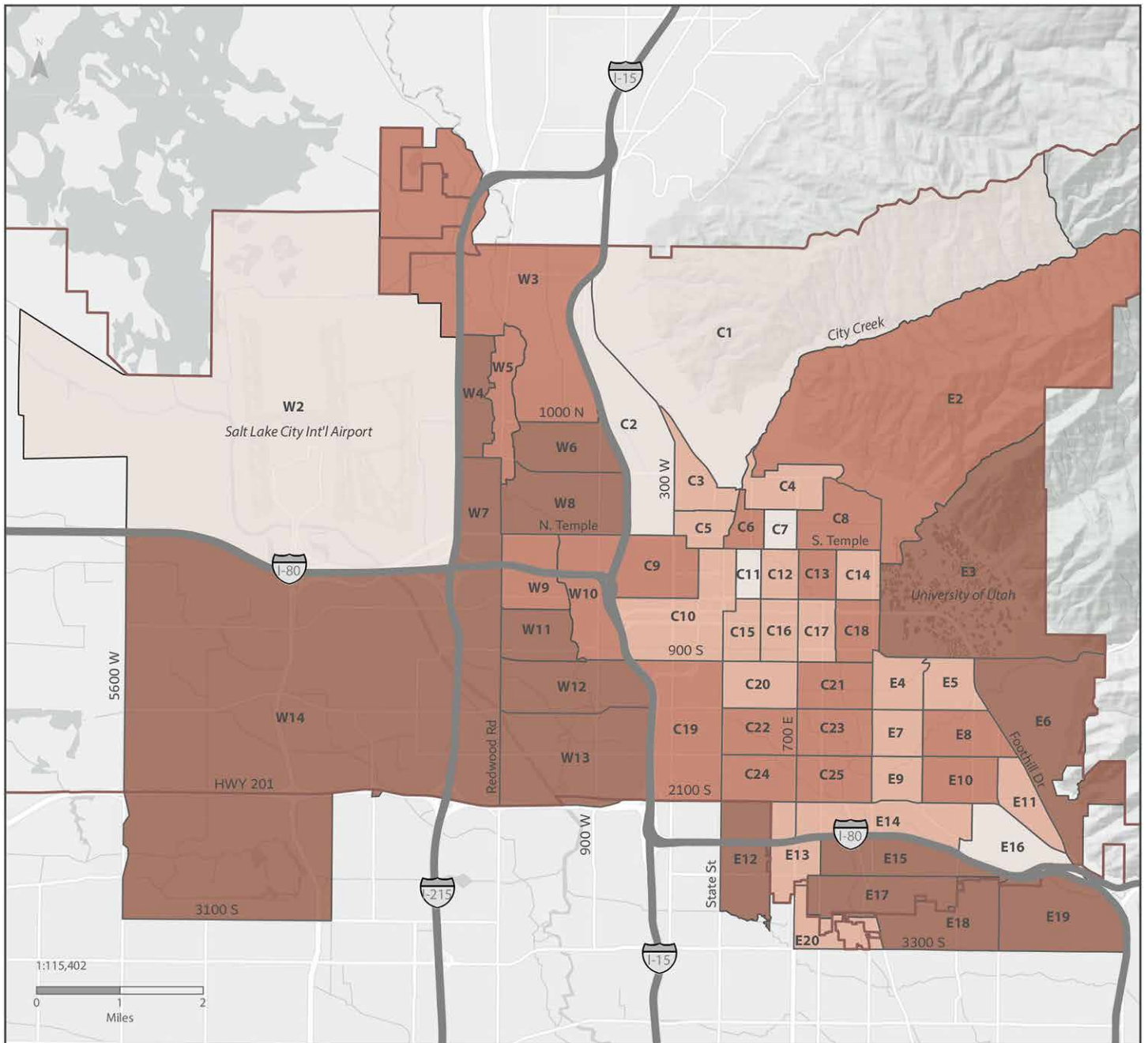
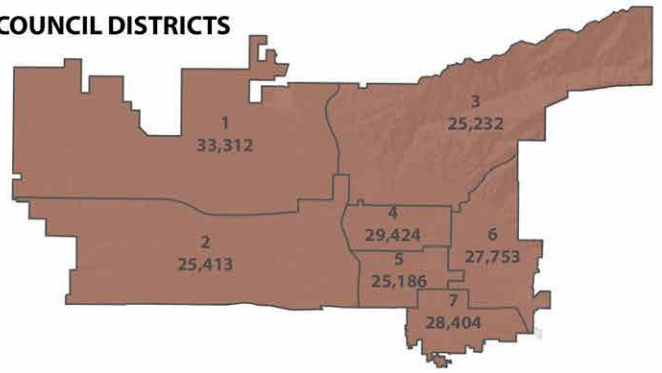
# Reference Figure R1: Total Population

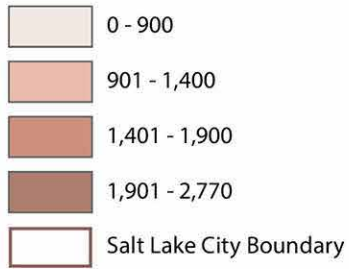

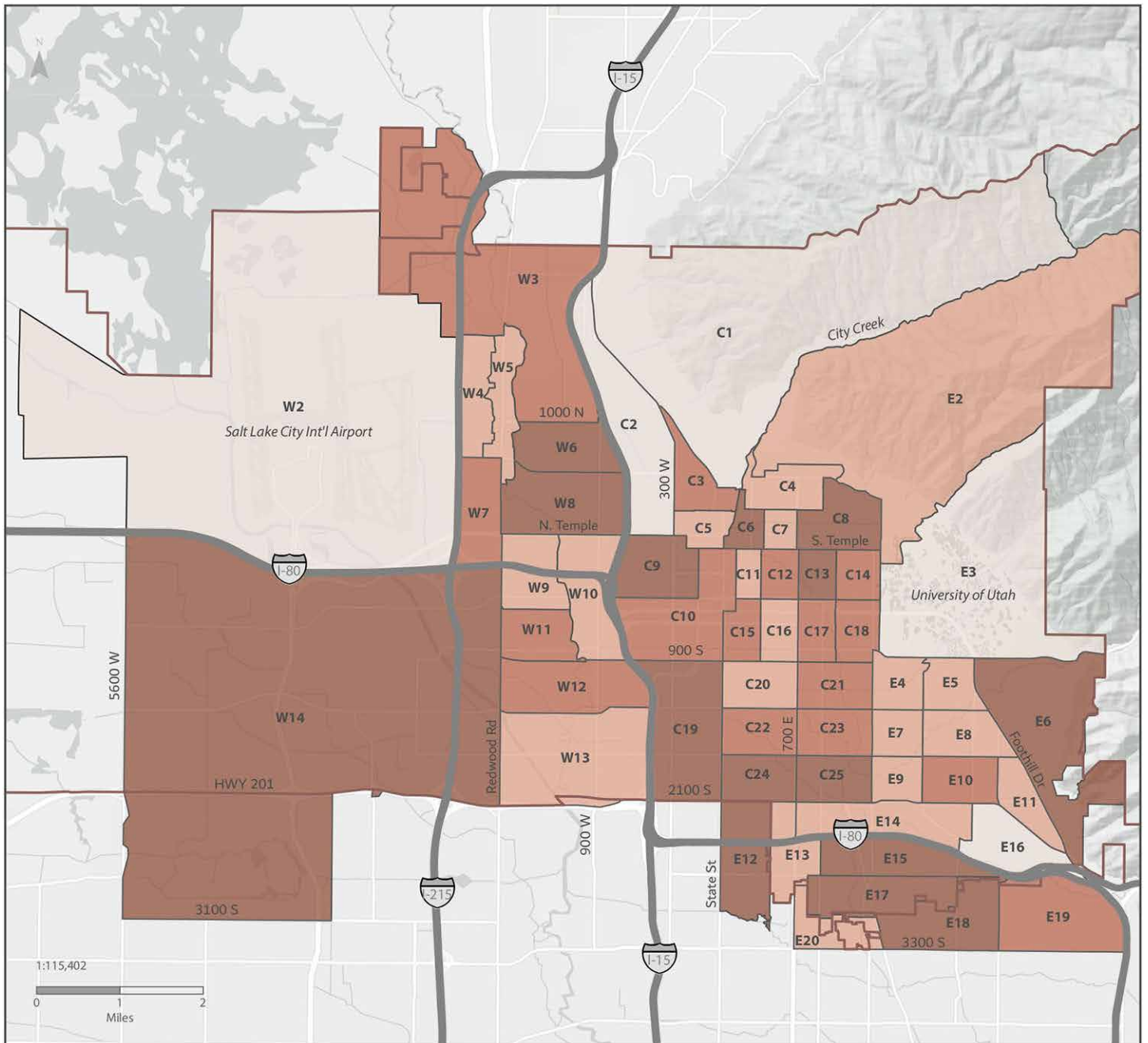
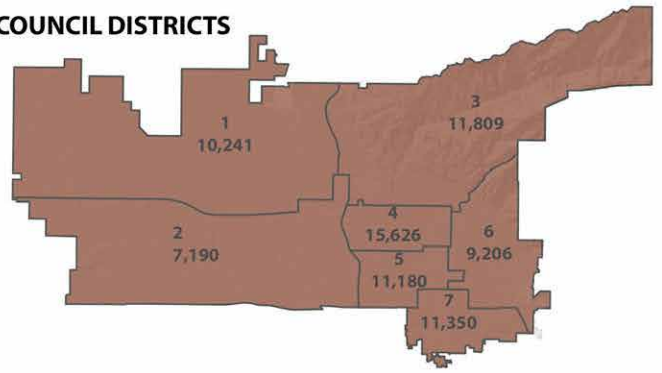
**Reference Figure R2: Total Households**

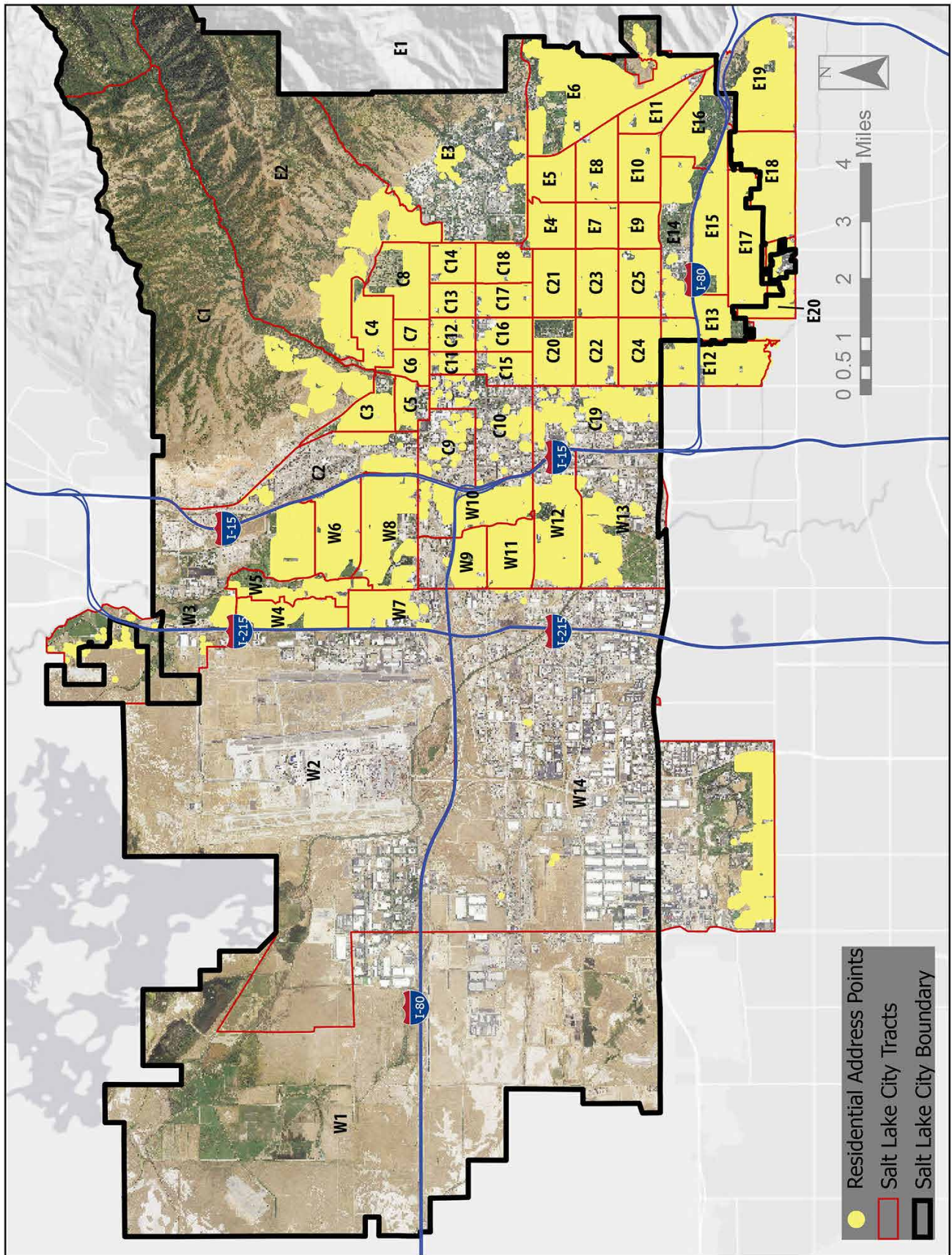
For the majority of the data subjects in this book, communities within Salt Lake City are examined at a census tract level of geography.<sup>16</sup> The 2014-2018 American Community Survey 5-Year dataset corresponds to the Census 2010 census tract geographies. Tract boundaries do not change between decennial censuses.<sup>17</sup>

Census tracts are sub-geographies of counties, and are not designed to correspond with place (city/town) boundaries. A small number of the tracts included in this book are only partially located inside the Salt Lake City boundary. The full geographic area of these tracts may include residents of other cities. The maps and tables in this book present data corresponding to the full tract area, with the exception of the Subcounty Population and Household Estimates section.<sup>18</sup> All tracts that have any portion within Salt Lake City are included in the data tables, and the tables denote which tracts have boundaries that extend beyond the city. Tracts E1 and W1 have

been excluded from maps due to the very large size of the tracts and their minimal numbers of Salt Lake City residents.<sup>19</sup> A tract reference map follows in this section. In addition, Figure 1 and Table 1 display shares of the 2010 tract populations which are within city boundaries, illustrating which tracts have populations divided by the city boundary. City boundaries are updated every year through the Census Bureau's Boundary and Annexation Survey (BAS) and are available in annual vintages. City level ACS 2014-2018 data match the 2018 city boundary.

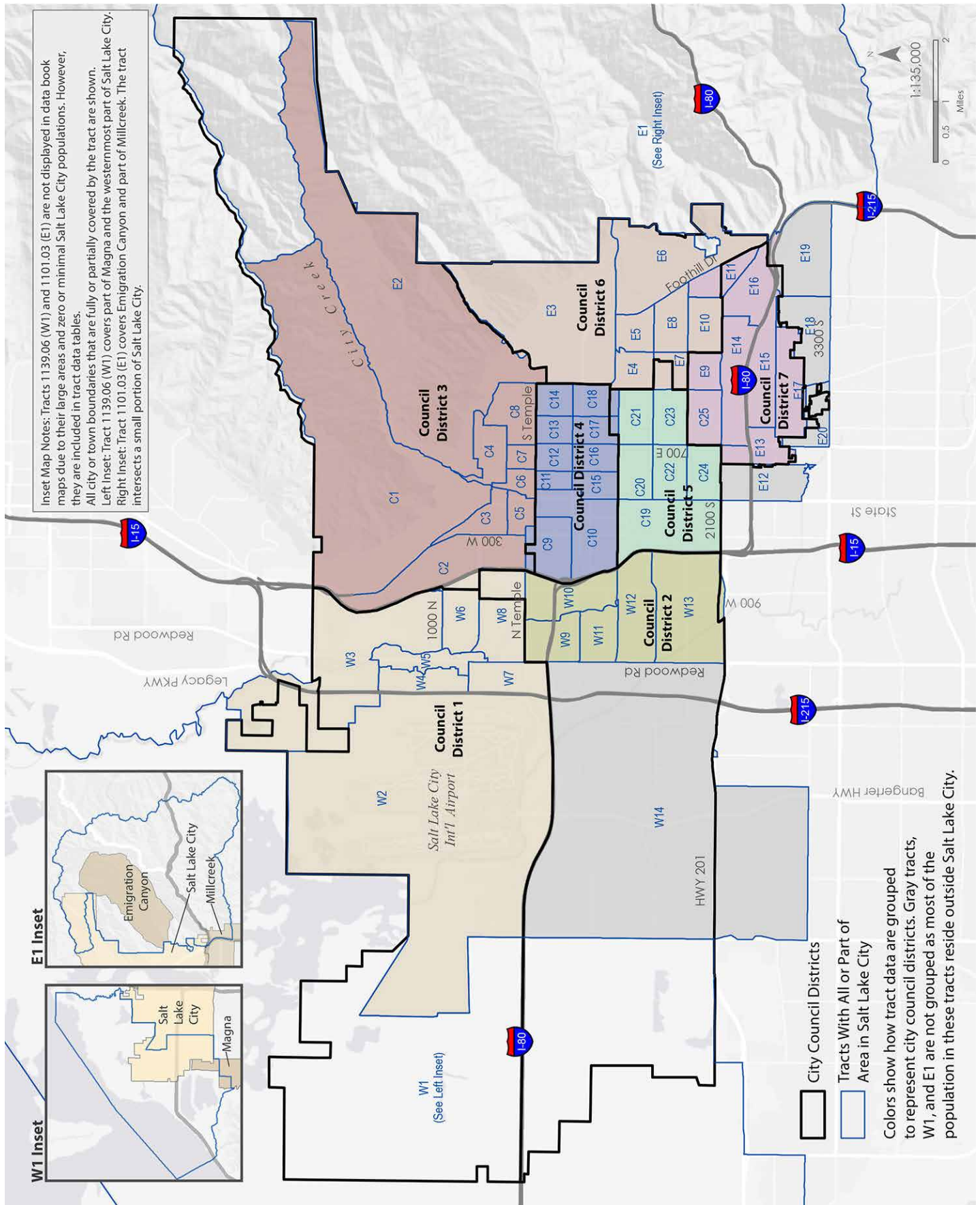
Tract codes shown in maps and tables were created by the Kem C. Gardner Policy Institute as an abbreviated method of referring to tracts. The letters W, C, and E in tract codes roughly correspond to west, central, and east areas of the city. When tracts are discussed in the text, a Salt Lake City community council may be used alongside the tract code to provide context for the tract location. The Salt Lake City Census Tract Reference Map displays both tract and community council boundaries.

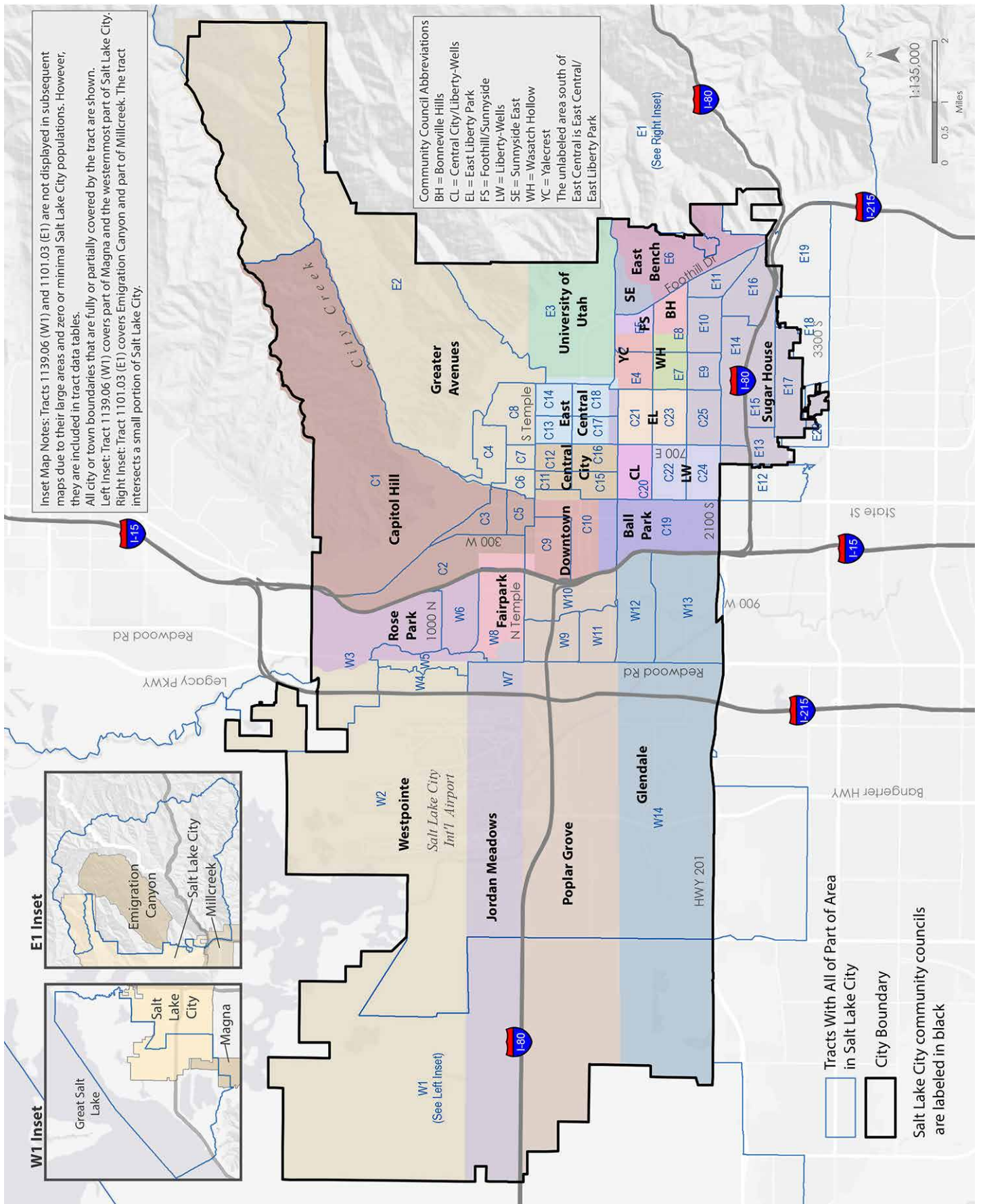
Reference Figure R4: Salt Lake City Census Tracts and City Council Districts

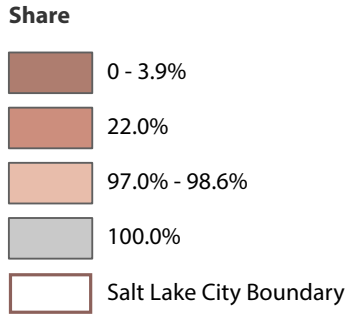
# Reference Figure R5: Salt Lake City Census Tracts and Community Council Districts



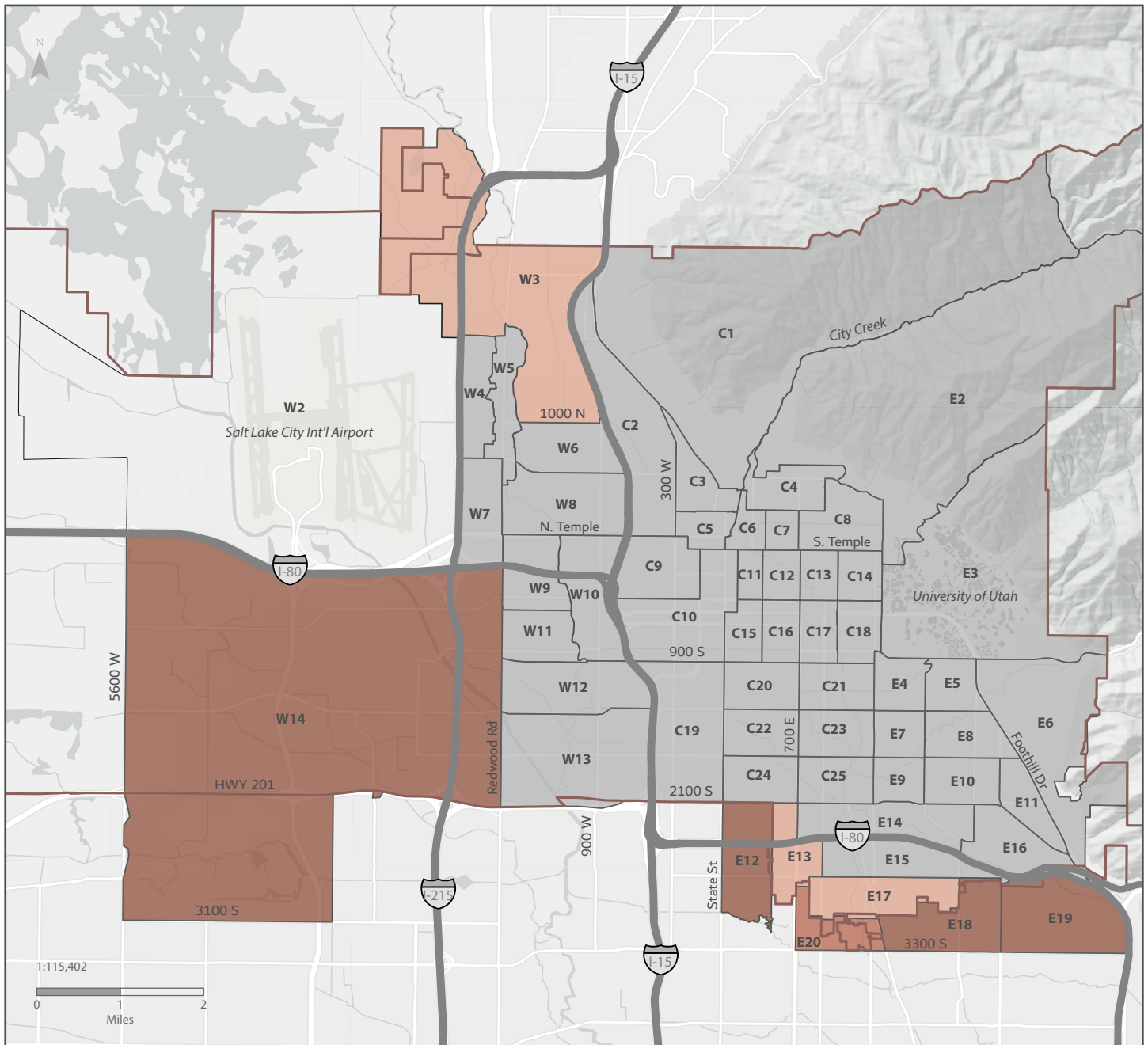
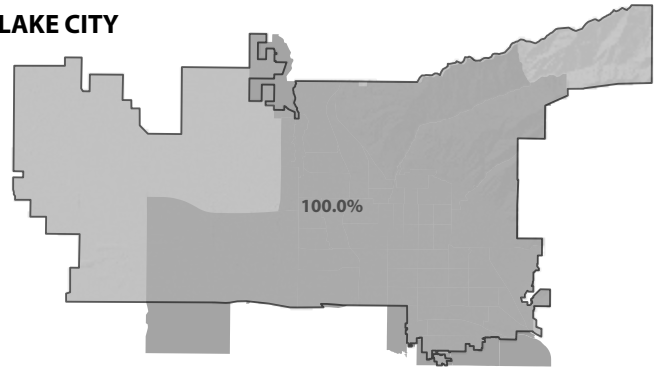

## Endnotes

1. The Census 2010 value is the Salt Lake City population adjusted based on the 2018 city boundary, which changed since 2010. Our estimate of the Census 2010 population for the new boundary area is 186,411. The population with the Census 2010 city boundary was 186,440 (29 higher in population).
2. The Census 2010 value is the Salt Lake City household count adjusted based on the 2018 city boundary, which changed since 2010. Our estimate of the Census 2010 households for the new boundary area is 74,499. The household count with the Census 2010 city boundary was 74,513 (14 higher).
3. Renter and owner-occupied housing unit counts are provided in Census 2010 data. In subcounty research, renter and owner categories do not necessarily represent actual owned or rented status for homes built after the 2010 Census. All new structures with at least 12 housing units are classified as renter-occupied for purposes of the research.

Though not shown in maps, data for these tracts is shared in each data table, where their tract codes are listed as W1 and E1, respectively. The city boundary has not changed since 2015.
