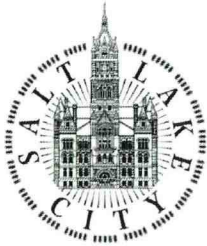


Board of Canvass Certification 2025 Municipal General Election




