Salt Lake City welcomes and values your input for potential capital improvement projects throughout the City. Constituent requests are accepted year-round and will be reviewed by the assigned City division (Engineering, Public Lands, etc). The City division will review your request to see if it aligns with current City priorities. If they find that it doesn't align with current City priorities, they will not recommend funding for your request. Please keep in mind that the City runs on a July - June Fiscal Year and that the CIP process takes at least one year to complete.

The constituent request must:

- Cost between \$50,000 - \$500,000 (cost estimates are conducted by the Engineering Division)
- Have a useful life of 5 or more years
- Be a Salt Lake City-owned asset
- Have Community Outreach or Alternative Public Engagement
