**EXCAVATION RESTRICTIONS**  
**2024 Construction Projects**

In accordance with Salt Lake City Code Section 14.32.085 (Excavation Restrictions), this publication identifies the public way projects scheduled for construction in Calendar Year 2024, including the nature of the excavation restrictions, and the effective date and duration of excavation restrictions. All potential users to whom the excavation restriction applies shall submit application to the City Engineer to participate in the stated projects to address co-locating facilities or other actions as needed in the best interest of the City. **CAPITAL IMPROVEMENT PROGRAM / 2024 STREET CONSTRUCTION PROJECTS**

**Reconstruction Projects:**

- 900 South from 900 West to 300 West
- 900 South from West Temple to Lincoln Street
- 200 South from 400 West to 200 East
- 1100 East/Highland Dr from Logan Avenue to Warnock Avenue
- 1100 East from 900 South to Logan Avenue
- 300 North from 300 West to 1000 West
- Virginia Street from South Temple to 11th Avenue
- West Temple from South Temple to 400 South
- 2100 South from 700 East to 1300 East

- West Capitol Street (Zane Avenue to Girard Avenue)

**Nature of Restrictions:** All utility excavations

**Effective Date of Restrictions:** October 2024 to October 2031

**Duration of Restriction:** Seven (7) years from completion date of project

- SLC Port GLC Phase 3 Plat "A" (700 North from 8000 West to 8460 West, 1000 North from 8000 West to 8460 West, 8100 West from 700 North to 1000 North, 8280 West from 700 North to 1000 North, and 8460 West from 700 North to 1000 North)
- Modera Marmalade (490 West from 400 North to 500 North)
- Crescent Subdivision (540 South from Redwood Road to 1800 West, and 570 South from Redwood Road to 1800 West)
- RMP 1300 West Development (1300 West from North Temple to 10 North, and Electric Avenue from 1300 West to 1350 West)
- Brooklyn Subdivision (Fayette Avenue from 450 West to 500 West, and 500 West from 965 South to 1000 South)

**Nature of Restriction:** All utility excavations.

**Effective Date of Restriction:** Date to be determined when street asphalt pavement is completed.

**Duration of Restriction:** Seven (7) years from completion date of project.
