Planning Commission Action:

This proposed ordinance makes the following amendments (for summary purposes only):

- Modifies Subsection 21A.62.040 to amend the definition of family and dwelling and add the definition of household.
- Deletes Section 12.56.515 to remove unenforceable language related to the definition of family from the parking enforcement chapter.

Underlined text is new; text with strikethrough is proposed to be deleted. Modifications made as part of the Planning Commission recommendation are highlighted in yellow. All other text is existing with no proposed change.

If adopted by the City Council, the Salt Lake City Council ordains the following, in substantial compliance with the following:

1 1. *Amends Section 21A.62.040 as follows:*

2 FAMILY:

- 3 ~~—A. One or more persons related by blood, marriage, adoption, or legal guardianship,~~
4 ~~including foster children, living together as a single housekeeping unit in a dwelling unit;~~
5 ~~or~~
- 6 ~~—B. A group of not more than three (3) persons not related by blood, marriage, adoption, or~~
7 ~~legal guardianship living together as a single housekeeping unit in a dwelling unit; or~~
- 8 ~~—C. Two (2) unrelated persons and their children living together as a single housekeeping~~
9 ~~unit in a dwelling unit.~~

10 Any number of people living together in the same dwelling as r required by Title 18.

11 The term "family" shall not be construed to mean a ~~club~~, group home, residential support
12 ~~dwelling, a lodge or a fraternity/sorority dwelling use. house~~

13 DWELLING: A building or portion thereof, which is designated for residential purposes of a
14 family for occupancy on a monthly basis and which is a self-contained unit with kitchen
15 and bathroom facilities. The term "dwelling" excludes living space within hotels, bed and
16 breakfast establishments, shared housing developments, rooming (boarding) houses, and
17 lodging houses,

18 DWELLING UNIT: See definition of dwelling.

19 2. *Deletes Section 12.56.515 as follows:*

20 A. ~~Definitions: For purposes of this section the following terms shall have the meanings herein~~
21 ~~prescribed:~~

22 ~~—EXCESSIVE VEHICLES: More than one registered vehicle per licensed driver in a household.~~

23 ~~—HOUSEHOLD:~~

24 ~~— 1. One or more persons related by blood, marriage, adoption, or legal guardianship,~~
25 ~~including foster children, living together as a single housekeeping unit in a dwelling unit; or~~

26 ~~— 2. A group of not more than three (3) persons not related by blood, marriage, adoption, or~~

Effective Date: This ordinance, if passed, shall become effective on the date of its first publication and shall be recorded with the Salt Lake City Recorder.
