9. **STATEMENT OF UNDERSTANDING:** The undersigned understands and agrees to abide by all SLC parking regulations, and the following provisions related to this program:
  - A. No person parking a vehicle without charge pursuant to this program shall park or permit such vehicle to remain parked in any parking meter space adjacent to a meter for a continuous period longer than that designated on the meter, nor shall they park in restricted spaces. In addition, no person shall, having left a parking meter space, reenter the parking anywhere along the same street block face within the same length of time as the posted meter time limitation plus thirty (30) minutes immediately following the vacating of the place of initial parking.
  - B. The motor vehicle described herein, is owned or controlled by the applicant (Controlled shall mean that the applicant has authorization from the registered owner to operate the vehicle on a full-time basis).
  - C. It is unlawful and in violation of the program for the applicant to falsely represent himself/herself as eligible for the City's “Green Vehicle” Parking Permit Program or to furnish false information on this application.
  - D. It is unlawful and a violation of the program for an applicant holding a valid “Green Vehicle” Parking Permit to allow the use or display of such permit on a motor vehicle other than that for which the permit is issued.
  - E. It is unlawful and a violation of the program for applicant to copy, produce a facsimile or otherwise counterfeit or attempt to use a falsified “Green Vehicle” Parking Permit.
  - F. Faithful compliance with the terms of the City's “Green Vehicle” Parking Permit Program by applicant is a condition subsequent to the privilege of obtaining and retaining a permit. Violation of the provisions of this program shall be deemed a forfeiture of those privileges.
