



Information:

The Fairpark Family Learning Center provides space for the community to access computer services, Health and Wellness, Digital and Financial Literacy classes and workshops. This Center offers free resources to the community including internet access, office applications, job search assistance, general computer assistance, scanning, email access and printing.

The Fairpark Family Learning Center is open to the public Monday - Friday, 9am - 8pm. This is an active work room. During these hours patrons are expected to utilize facility services for job searches, scanning, printing, and receiving tech help. For one hour per day, patrons may use the Fairpark Family Learning Center recreationally for playing video games, watching YouTube videos and listening to music on computers.

Free Classes and Workshops:

Love and Logic Parenting

Love and Logic Parenting classes provide tools and strategies to create healthy relationships between children and parents.

Money Smart for Adults

Money Smart basic finance courses will give participants practical knowledge, skill building opportunities and resources that can help manage their finances. Classes will be taught on 14 different modules about various topics.

Digital Literacy for Adults

We have a variety of digital literacy classes taught at our center. Classes include: Basic Computer Skills, Internet Basics, Using Email, Windows 11, Mac OS (operating system), Intro to Microsoft Word, Intro to Microsoft Excel, Intro to Microsoft PowerPoint, and Intro to Google Docs.

Workshops

Occasionally we will teach shorter classes in the form of workshops. These workshops will cover topics related to our longer class series like basic finance, digital literacy, and family health and wellbeing.

Anti-Bullying Policy Agreement

Purpose

Salt Lake City's Division of Youth and Family is dedicated to ensuring the dignity and safety of all youth being served in Salt Lake City. This policy prohibits bullying, harassment, and intimidation in all youth-serving city services, activities, programs, and facilities within Salt Lake City's Division of Youth and Family.

Definitions

"Bullying" shall be defined as any severe, pervasive, or persistent act or conduct whether physical, electronic, or verbal that:

1. May be based on a youth's actual or perceived race, color, ethnicity, religion, national origin, sex, age, marital status, personal appearance, sexual orientation, gender identity or expression, intellectual ability, familial status, family responsibilities, matriculation, political affiliation, genetic information, disability, source of income, or any other distinguishing characteristic, or on a youth's association with a person or group with any of the actual or perceived foregoing characteristics; and
2. Can reasonably be predicted to:
 1. Place the youth in reasonable fear of physical harm to their person or property;
 2. Cause a substantial detrimental effect on the youth's physical or mental health;
 3. Substantially interfere with the youth's academic performance or attendance; or
 4. Substantially interfere with the youth's ability to participate in or benefit from the services, activities, programs, facilities, or privileges provided by the Division of Youth and Family.

Prohibition against Bullying

1. Acts of bullying, including cyberbullying, whether by youth, volunteers, or staff, are prohibited in all youth-serving city services, activities, programs, and facilities.
2. Retaliation against a youth, volunteer, or staff member who reports bullying, provides information about an act of bullying, or witnesses an act of bullying is also prohibited.
3. All Salt Lake City's Division of Youth and Family services, activities, programs, and facilities for youth shall establish a clear policy for reporting, addressing, and preventing bullying as defined above. This policy shall include a requirement for annual training for all staff on said policy and on best bullying prevention practices.
